6. **PLEASE NOTE**:

A street collection permit does not authorise you to use any land or property without the consent of the occupier.

It is a criminal offence to collect money or sell articles for charitable or other purposes without a street collection permit.

Only one street collection permit will be issued to a single organisation on any one day in a particular area.

Felixstowe -if you wish to use the Promenade, or The Triangle in Hamilton Road, specific permission is required from the Regeneration Team (Events) <u>events@eastsuffolk.gov.uk</u>. The sale of goods, with the proceeds going to charitable causes, taking place on The Triangle, will be allowed at the same time as a street collection on Hamilton Road. Otherwise a street collection permit would only be issued relating to either Hamilton Road <u>OR</u> The Triangle (not both) on any one day.

In **Lowestoft** only <u>one</u> street collection permit can be applied for in advance (for any time) by one charitable organisation. If further dates are required an application can be made <u>no more than six weeks</u> before the planned collection.

In **Beccles, Bungay, Halesworth and Southwold** <u>three</u> dates can be booked in advance by one charitable organisation, with further requests for additional dates applied for <u>no more than ten weeks</u> before a planned collection.

<u>Rubbish</u>

Please note, all rubbish from the street collection must be taken home with you, it must not be put in or near a public bin, as this is classed as 'fly tipping'. Anybody found guilty of fly tipping can be fined up to £50,000.

Popular collection sites:

BECCLES:	Exchange Square
BUNGAY:	Market Place and St Mary's Street (Buttercross)
FELIXSTOWE:	Hamilton Road and The Triangle
HALESWORTH:	Thoroughfare
LOWESTOFT:	London Road North (outside B & M store)
SOUTHWOLD:	Outside the former Lloyds Bank and Market Place

N.B. For **Southwold**, charity stalls are only permitted in front of the former Lloyds Bank and can only be booked for Mondays, Thursdays and Saturdays.
