

The Environment Agency have just updated their flood warning website widget, and if you have the old style widget on your website you will need to change it to the new one. More information can be found on page two.

The Joint Emergency Planning Unit

(JEPU) are currently looking at the existing strategy for community emergency planning in Suffolk. One of the issues that has been identified, is that many CEP groups only have one routine contact. We are therefore, encouraging every group to let us have at least two if not three alternative contact details. This will ensure that when necessary we can ensure that each group receives information even when the main contact isn't available or can't be contacted. It would be helpful if you could forward these contacts to your local emergency planning officer. You'll find their contact details on Page

You'll see some subtle changes still occurring on the map in terms of parishes that have opted to engage with the scheme. Over the summer we are making a concerted effort to contact all the white Parishes (those that have not yet responded to the survey) so that by the end of August, there will be no white spaces left on the map. Any parish that we haven't heard from by that time we will turn red. The colour which represents that a parish has no intent to formulate a plan at present. This will enable us and the steering group reps, to focus our support where it is most needed. If this applies to your Town or Parish, then please contact us to confirm whether you are interested or not at this time. If you would like to know more about what's involved in starting a plan, what support is provided etc., then why not book into our free workshop at West Suffolk House on the 27th July from 09:30—12:30 . Please remember that it doesn't have to be the town or Parish Council that has to produce the plan, it can be any community group.

The Environment Agency has developed a new flood widget which can be placed on any website to show flood warnings.

The new widget replaces the existing version that may feature on your website.

In April 2012 we developed and launched a flood widget. The flood widget is computer script or code that web developers can use and embed within any website.

It provides live information displaying the number of Environment Agency flood alerts, flood warnings and severe flood warnings in force.

The flood widget uses the Environment Agency's open data and provides the latest summary of flood alerts and warnings. The widget is designed to update every 15 minutes.

The Environment Agency is carrying out a large programme of work to review and improve its flood services. The flood widget is one of those services. The widget has proven popular since it was launched in 2012. We have reviewed the need for the widget and have made some improvements to how it looks.

#### The new flood widget

The new widget has been re-designed to provide either a national (England) view or a county-based view.



We launched the new widget on 8 April 2016. Both the old and new widget will be available for around 8 weeks

#### Updating your website

If your website features the existing flood widget, you should replace it with the version which can be downloaded from <a href="https://environment.data.gov.uk/flood-widgets">https://environment.data.gov.uk/flood-widgets</a>

You can choose which design and location you want to feature. The old widget will only continue to work till the end of May 2016. It is important that you update your website with the new widget before June if you want to continue to receive the service.

If your website visitors require flood warning information for Wales they will be unable to get this through the new widget.

Natural Resource Wales (NRW) are responsible for the flood warning service in Wales and they don't currently plan to provide an alternative widget.

# Raynet in Suffolk Supporting **Community Emergency Planning**

It has gone down in history as one of Britain's worst storms with the loss of 307 lives, but something worthy came out of the East Coast Flood Disaster with the formation of a national emergency communications organisation which still serves the public over 60 years later.

On the night of January 31st and February 1st 1953, Britain was battered by gale force winds and a tidal surge which swept down the East Coast, raising sea levels six metres above normal and breaching flood defences in 1,200 places. In the Irish Sea, the ferry Princess Victoria sank with the loss of 133 lives.



Telephones and Coastal Radio Stations were put out of action, but Radio Amateurs came to the rescue. Humber Radio was dealing with a distress call from the SS Levenwood, which had requested the help of tugs and urgent medical advice, when it lost power and went off air.

But Radio Amateur Reg Hutcheson-Collins was monitoring and he arranged for a tug to go to the Levenwood's aid and got medical advice from a local hospital which he passed to the ship's master. That night Reg answered four distress calls, including one from the Humber Light

At the time Radio Amateurs were licensed to speak to each other, but were not permitted to pass what is now known as "third party traffic", so the regulations had been broken. Although Radio Amateurs worked for MI5 during the Second World War monitoring Morse code signals - submitting 23,000 logs a month, the Radio Society of Great Britain's offer to provide an Emergency Amateur Communications Service was rejected by the Government in 1950.

The East Coast Flood Disaster resulted in an urgent rethink. The Amateur Licence was amended to allow the passing of third party traffic on behalf of a Government-approved list of "User Services", including the police, fire and ambulance, and in November, 1953, the Radio Amateurs Emergency Network was formed.

In the 60 years that have followed RAYNET, which has around 2,000 members nationwide but no paid staff, has provided emergency communications at many major incidents, including the Lockerbie air disaster where up to 200 people a day operated for 10 days until recovery of the 270 dead was complete.

The Lockerbie Official Report said RAYNET had made a vital contribution and the organisation should be considered as an integral part of future planning arrangements. "The facilities and co-operation of the RAYNET teams were essential to the management of the emergency and its search and recovery operations."

Today the "User Service" list has been extended to all Category 1 and 2 Responders as defined in the Civil Contingencies Act 2004. They include

Police, Fire and Ambulance services, Emergency Planning Officers, Coastguard, health authorities, public utilities, St John Ambulance, British Red Cross, Salvation Army and RVS.

Everywhere RAYNET goes, it starts with nothing and engineers and operates a radio system to meet the needs of its users. But RAYNET also keeps detailed paper logs of all radio traffic and has the ability to record all messages to a computer hard drive, which can be accessed for any future inquiry.

RAYNET members today are dedicated to providing a professional communications service to our User Services and event organisers, and remain ready to be called upon in emergencies. We have two active groups in the Suffolk county area one covers the East the other covers the West.

### Flood Re

April saw the launch of Flood Re, a new national scheme designed to help provide better access to affordable home insurance for households not only in high flood-risk areas, but for those affected by significant surface water flooding across the UK.

It represents a long-term, sustainable approach to providing home insurance for those at flood risk.

The Suffolk Joint Emergency Planning Unit, amongst others, have been actively promoting this initiative to both existing Community Emergency Planning Groups and Parishes across the County. We have recognised that the existing strategy for CEP now needs to be reviewed to reflect those changes. Also, to ensure that we continue to facilitate the right workshops, training, templates etc. that you need to keep your plans alive, and to ensure that your volunteers are adequately trained. Work is currently

ongoing to update the strategy that steers the way forward for community emergency planning in Suffolk. We hope to be able to share the finalised version with you in the next edition of this newsletter.

Members of the Steering Group supported JEPU at the Suffolk Show promoting CEP. We ran two competitions; one for children on the top 10 things they would take with them if they had to leave their house as a result of an emergency. For the adults it was a bit more challenging—they had to list 10 areas they would cover in a personal household emergency plan. This certainly got a few people thinking about things they had never considered in the past. The Children's winner was Jasmine from Rendlesham who wins a trip to a local Fire Station provided by Suffolk Fire and Rescue Service. The adult winner was Alison from Leiston, who won a grab bag awarded by the Environment Agency.

### Workshop for New Groups

The next workshops for parishes wanting to find out more about Community Emergency Planning, or thinking about starting a plan is taking place on the 27th of July at West Suffolk House, Bury St Edmunds IP33 3YU. This will be a morning meeting and is open to anyone interested from across Suffolk

Rest Centre Training

We continue to open our Rest Centre Training for Council Staff and Managers to volunteers from your CEP groups. However, if there is enough demand, we can run an evening session for anyone that is working and is unable to attend day time trainings. Dates will be circulated to all Community Emergency Planning Groups when these are scheduled and publicised in future newsletters.

Places for all workshops are currently free of charge and can be booked by emailing emergency.planning@suffolk.gov.uk. Any CEP Volunteers can attend these sessions, irrespective of which local authority your Parish or group falls within. Please note that training is not just for your core group, it's for any of your volunteers.

Our community is growing, however there are still areas of Suffolk where we have yet to forge any community partnerships, and get new groups and plans off the ground. We need all the help we can get to encourage more Towns, Parishes and communities to come forward and take up the challenge.
