



In this day and age most people have had some involvement with computers, and an awful lot of stuff can only be done on the internet. With this in mind the Council has started rolling out the provision of free internet to the residents in our sheltered housing schemes to help get them 'on line' and enjoy the benefits of the World Wide Web.

Residents at Jubilee Court in Halesworth and Crick Court in Southwold are the first to have WiFi installed and had free training funded by the Housing Department to help them understand how it works and start using emails and browsing the internet.

The training and the introduction of WiFi has been extremely popular and we have had several of the residents now buying their own tablets and computers and becoming real Silver Surfers! The next step is to provide more training to encourage residents to Skype with their families around the world as well as using online shopping and hopefully save themselves some money.

This is a great example of the changes we are making to our Sheltered (or Retired Living) schemes and the benefits of living in a shared communal environment.

What can your **Local Councillor** do for you!

Your Waveney District Councillors are here to help and they can assist you in a number of ways. For example if you have problems with your housing such as poor maintenance of council properties, they can assist by liaising with your maintenance officers to try to get this sorted. If you have issues with noise from neighbours they can work with nuisance officers to try to get these resolved. In turn your Councillors are a great way of getting the best from the facilities and services provided by your council as they can work with you and the council to help you make the most of these. They can arrange for fly-tipping and rubbish to be cleared and they can help you address problems with overgrown verges or hedges on public land, to name but a few. They can also help you access other non-Council support and services through directing you to other appropriate organisations such as various local charities or social care services, to help with a wider range of issues. To contact your local Councillor either go on the website www.waveney.gov.uk 'Your Councillor' and put your postcode in to the search engine to find your relevant ward (local area) councillor or call 01502 562111, which will put you through to customer services and they will be able to give you the details of your ward councillor. In most instances both a mobile and home number, and email address, will be provided on which your Councillor can be contacted. Most wards have two or three councillors providing a wider basis of support for you to use. Explain to your Councillor your concerns, and issues and they will try to assist you to the best of their abilities and in a timely manner.

Homeless Families Taking a Pride in Coppice Court

The Council was recently able to give the go ahead for a garden to be developed at Coppice Court in Lowestoft. Coppice Court is supported housing accommodation working with 24 homeless families. The building is owned by Waveney and the support is delivered by Flagship Housing (Care and Support). The support on offer to the families is a wide range of housing related support to help all families to gain the skills to live independently in the community.

Flagship Housing each year fund raise for a chosen charity and for 2014/15 the charity they chose was the Care and Support projects – the staff team at Flagship Housing and RFT raised £500 for the project.

Organising and managing the ideas was led by Resident Representatives and the staff team. The vision was explained to excited residents who saw an opportunity to provide a lasting meaningful addition at Coppice Court

Volunteers were organised into work parties and given instructions. The day was led by 2 members of the team and 2 residents living at Coppice Court. We had many volunteers to help on the day which were Coppice Court residents and their children, Flagship Housing and RFT staff. Flagship Housing and RFT staff volunteered a day of their time to help with the project.

Building up to the day much thought was given to choosing the plants. One resident chose Celosia because; she said "it reminded me of my Grandad" and many chose for similar reasons.

A massive thanks to all who donated to the Garden Project and took

part to make a lovely outside space for our families here at Coppice Court to enjoy.

PAINT AMNESTY Recycling & Sustainability

Waveney's Housing Maintenance Team are joining forces with Crown Paints and Brewers to provide a bespoke paint amnesty for a 2 week period in the spring, dates will be confirmed in the next edition.

This offer will be purely for all our tenants who have old paint to dispose of, as recycle/refuge sites will not accept any part filled paint containers, and hopefully prevent unnecessary recharges when the property becomes empty or disposal cost to the Authority from fly tipping.

The paint amnesty will cover all brands of oil based products, water based emulsions, acrylics

and stain preservatives, and not just Crown products.

All products collected will be transferred to Crown paints recycling plant that was set up employing people with learning disabilities and long term unemployed.

This is a very generous offer by both Crown and Brewers and we are very keen not only to take part, but promote this as we have never been offered this opportunity before by any other companies.

HOW DOES IT WORK?

Crown will supply Brewers with storage crates at their branch in Whapload Road Lowestoft,

tenants will take their unwanted paint to Brewers who will not only dispose of it but will give a free roller pack on receipt and Crown will offer a £10.00

off voucher paint when spending £40.00 or more on their products for people who wish to purchase more paint, although this branch is sited in Lowestoft this offer is open to all our tenants in Waveney.

Because this offer is exclusive to our tenants proof will be needed via your tenancy agreement!

Evelyn's granddaughter registered her onto Gateway to home choice and she was soon able to bid and view a Council sheltered scheme flat which was located on

Keep Those Presents Safe for Christmas

Christmas coming up which means presents under the tree wrapped and ready to be opened... Let's hope though not by some uninvited guest ready to steal or damage and wreck your Christmas. It isn't just the time for giving, some people think it is the time for taking too! There are some simple tips that will help you protect your home and presents from the thieves.

- Arrange for parcels to be delivered with neighbours if you're going to be out. Don't have them left by doorways or open shed doors.
- Make sure presents and valuables aren't visible through windows.
- Secure all doors and windows before you leave home even if you're only away for a short while.

- Don't keep house or car keys in obvious locations or anywhere near the front doors.
- Never leave a door key in a convenient hiding place, like under a flower pot etc.
- Use a door chain if you have one before you answer the door.
- Be aware of uninvited callers - always check identities and if in doubt don't let them in. If they are genuine they will not mind at all as all companies and this Council require an identity badge to be shown.
- Don't advertise that your home is empty - if you are going away, be careful who you tell. Consider who may have access to messages that you put on social media.

Are you behind with your rent? Particularly, are you behind with your Council Tax? Does the threat of court action loom high in your direction?

What if, through means you cannot control - you receive that dreaded summons for unpaid council tax? Even if you are out of work, a single parent on a low income, the elderly scrimping hard to make ends meet? All have to pay council tax in one form or another. But what if you can't? Even if the debt is small - say \$50 for argument's sake, or even less? What if you are unable to pay, through no fault of your own?

What many do not realise and what concerns those of us working in the community, is that once upon a time your court fine included a one-off court cost. Today, it seems not only do you pay the fine and court costs per se, but also additional fees implemented without mercy on the day ("administration" charges, et al) pushing that £50 non-payment higher, say up to £150 if not more, for example, which for those in dire financial straits pushes them into an even worse situation.

Today, it becomes the choice whether to feed the children, pay the rent or pay the council tax; a frightening position to be forced into. The additional threat of bailiffs turning up on the doorstep because of the court's slowness even if the debt is paid, adds considerably to an already stressful situation.

and also have the power to put pressure on private landlords of unruly tenants. The question is – how often do they use them?

In these days of estates with a mixture of council tenants, housing association tenants and tenants of private landlords; how safe are we when harassed by those who are tenants of private landlords? Especially those of us living next to private tenants whose landlords don't care as long as the rent is paid, or those of us who live next to properties owned by absentee landlords?

What if we, as council tenants, are threatened with physical abuse or harassment? The first action, of course, is to contact the Police. Next is to contact your housing officer as soon as possible. The only problem at this point is that in the past council tenants have had the impression, albeit misleading, that the council tended to shy away from problems caused by private tenants.

All landlords, social and private, are governed by the same laws regarding antisocial behaviour and harassment, especially if it is racial. Councils and housing associations have powers to control the matter

In the meantime, what can you do? Firstly, if the police are needed quickly, dial 999. The problem has to be reported and where the police are involved, always get a crime number. This will act as a reference both to the police and the council, and will also prove useful when you contact your housing officer. Contact both your tenant rep and your local ward councillor if you need further help. If noise is a particular issue, you can also contact Waveney District Council's Environmental Services Noise Enforcement Officer, Mike Hill (contact number on the back page of this issue).



Gun on Bapt st Church

Lowestoft's older Gunton Estate is one of those estates that have that rarity – a real community hub. The shops in Hollingsworth Road, the Community Hall nearby on the corner with Montgomery Avenue and opposite, Gunton Baptist Church, a building which marks seventy years of a movement on the estate which began in 1946 in a prefab living room in Spashett Road. Its first purpose-built structure, the Baptist Hall, was consecrated in 1951. The church itself was built in the early 1960s.

The arrival of its long-serving minister, Colin Napper and his wife Jan saw the start of a closer involvement with the community culminating with the eventual founding of the Gunton Community Partnership with Tenant and Resident Association chair, Ann Hubbard, as well as the establishment of the Gunton Community Park. The latter years of Colin's incumbency also saw the creation of a number of community projects, notably the Signpost Dreamworx project.

The reverend Napper retired in September 2010 after thirtyone years at Gunton. The present minister, the reverend June Love arrived in 2011, soon placing her own mark on the church, founding the Hub Café in 2013, continuing the Dreamworx project, and setting up the East Suffolk Food Bank. Today the church is also its busiest donation and collection point.

Although she has been at Gunton for only four years, the reverend Love has been very active. The latest project is for an extension and to make the whole building disabled friendly. Up until now the church and its community area have been on two levels. Fundraising for the new extension has been on-going since 2013 and has included a variety of special events, including a 25 mile sponsored walk from Norwich to Lowestoft and an auction which raised approximately £800. Building the extension started this summer and once finished will include an expanded Hub Café and Clothes swap-shop, as well as easier access to the church.



Satisfaction Survey June 2015 to September 2015




How Satisfied were you with the service provided by the Housing Team?



How Satisfied were you with the quality of your home?




How Satisfied were you with the maintenance to your home?
