#### 3 SZC PLANNING TRACKER

NP provided update on the SZC planning tracker.

#### **TCPAs**

- Wild Aldhurst enhancement work number of items to be closed out. SZC working through these outstanding items.
- Saxmundham Road Level Crossing should be submitted in next few days.
- Construction Electrical supply 132 kv to be submitted within next month.
- Natterjack Toad to be submitted end of June 2024. Delivery to commence in September/October 2024.

#### DCO Requirements:

- R2 Noise Monitoring and Management Plans (NMMPs) have been re-submitted (Rev 02). ESC finalising discharge.
- **R2** Soil Management Plan (SMP) Site wide plan is currently being finalised for discharge and other SMP, ESC has had comments raised by SCC that need addressing.
- **R2** Dust Monitoring and Management Plan (DMMPs) ESC Environmental Protection raised comments, SZC has addressed and provided tracked change draft. Clean version to be submitted in due course.
- **R3** Written Scheme of Investigation (**WSI**) for 2 Village Bypass (VBP) to be submitted soon. Additional WSIs to be submitted in Q2 2024 Site of Special Scientific Interest (SSSI) crossing southern abutment (currently being drafted), Halesworth Fen Meadow and Pakenham Fen Meadow WSIs also being prepared and pre-submission consultation to occur with Historic England.
- **R4** Main Development Site (MDS) Terrestrial Ecology Monitoring and Management Plan **(TEMMP)** updates being prepared.
- **R5** earthworks phase 1 document submitted. Consultation ends this week informal comments have been provided by Suffolk County Council (SCC) Lead Local Flood Authority (LLFA). Phase 2 earthworks drainage document to be submitted in next quarter engagement with key consultees in advance.
- **R9 Site clearance** Associated Development (AD) work package and additional clearance above what has been consented in DCO plans. Awaiting updated drawings from WSP. Likely to be submitted Q2 2024.
- **R10** Public Rights of Way (PRoW) implementation plan Coast path. Feedback from AR on coast path walk and draft has been shared with AR this week aim to formally submit in shortly, unlikely in Q1 2024.
- **R11** Water Monitoring and Management Plan (WMM**P)** Officer report being finalised, should be ready for internal sign off in the next week.
- R18 Sports Facilities. SZC to submit in Q2 2024.
- R20 SSSI crossing (temp and permanent crossing) SZC to provide details in Q2 2024.
- **R21** Sizewell Marshes SSSI Method Statements SZC will submit Q2. Discharge for veg. management to be discharged soon, ESC finalising report.
- **R23 Highways Works** Lover's Lane access into the Ancillary Construction Area (ACA)/Land East of Eastland's Industrial Estate (LEEIE) once closer to technical approval will pull out the right drawings and submit to SCC for discharge. ## 4 WORKING GROUPS UPDATE / NORTHERN TRANSPORT FORUM CHAIR

RB provided update. Detailed designs are progressing well and SZC currently trying to set up meetings with all working groups in Q2 2024 to agree what the final schemes are going to be and what will be delivered.

RB discussed few ongoing topics:

- Westleton currently going through a consultation with Parish council on the B1125 scheme (responses expected end of March).
- Request to look at average speed cameras in Westleton for consideration. Active point of engagement with council and conclusion anticipated April 2024. Issue of impact on the conservation area has been raised once detail received, this will be shared with all relevant parties and first action is for liaison with police.

SZC aiming to deliver mitigation as soon as possible – in the programme for Q1 2025. SZC need to be in position that designs and scope are finalised, procurement process is implemented, contractors are taken on-board and plan of delivery is worked through. SZC to keep working group updated on status of this.
