Hi Hilary

I had spotted there were two applications but in my haste I forgot to add an 's' to the word 'application' to signify I had considered both designations. I had initially been curious over the omission of the BT Adastral Park site from the Martlesham NP area and wondered why this had not been included within its geographical area. However, I subsequently noted the Council view on this which seems fine. I do not think the overlap between the two NP areas raises any specific issues for us nor do we have any preferences. Similarly from a planning perspective we have no specific view on whether the part of Martlesham area within Woodbridge area should be treated more as part of Woodbridge or the Martlesham parish area.
