## Recreational Disturbance Avoidance and Mitigation Strategy Supplementary Planning Document (SPD)

## Adoption Statement May 2021

This statement is published by East Suffolk Council to fulfil the requirements of regulation 14 of the Town and Country Planning (Local Planning) (England) Regulations 2012 (as amended).

Recreational Disturbance Avoidance and Mitigation Strategy Supplementary Planning Document (SPD) was adopted by East Suffolk Council on the 4<sup>th</sup> May 2021. The SPD supports the implementation of the Suffolk Coast Recreational Disturbance Avoidance and Mitigation Strategy, which mitigates for the impact of increased housing growth on protected Habitat Sites.

Consultation was held on the draft SPD between 19<sup>th</sup> October 2020 and 7<sup>th</sup> December 2020. The Council has modified the SPD to consider representations made in relation to the document and any other relevant matters. Modifications arising from the consultation are set out in the Consultation Statement.

Any person with sufficient interest in the decision to adopt the SPD may apply to the High Court for permission to apply for judicial review of that decision. Any such application for leave to review the decision must be made promptly and, in any event, not later than 3 months after the date on which the SPD was adopted.
