## THE SUFFOLK COASTAL DISTRICT COUNCIL (OFF-STREET PARKING PLACES) (VARIATION) ORDER 2018

The Suffolk Coastal District Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 32, 35 and 101 of the Road Traffic Regulation Act 1984 (as amended) (hereinafter referred to as "the Act of 1984") Schedule 9 to the Act of 1984 and all other enabling powers and with the consent of Suffolk County Council in accordance with Section 39(3) of the Act of 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order.

#### **PART 1: PRELIMINARY**

#### 1. <u>Title</u>

This Order may be cited as the Suffolk Coastal District Council (Off-Street Parking Places) (Variation) Order 2018.

### 2. Commencement and Effect

This Order shall come into operation on the 1<sup>st</sup> April 2018.

Save as varied by this Order the Suffolk Coastal District Council (Off-Street Parking Places) Order 2008 ("the 2008 Order") as varied by the Suffolk Coastal District Council (Off-Street Parking Places) (Variation) Orders 2010 ("the 2010 Variation"), 2012 ("the 2012 Variation"), 2013 ("the 2013 Variation"), 2013#2 ("the 2013#2 Variation") and 2015 ("the 2015 Variation") will continue to apply.

With effect from the 1<sup>st</sup> day of April 2018 the 2008 Order (as varied by the 2010, 2012, 2013, 2013#2 and 2015 Variations) shall have effect with the following variations.

#### **PART 2: VARIATIONS**

- 3. Applications for Special Filming Permits are made available.
- **4.** The limits of "Dock Viewing Area" car park are amended. Its location and extent are shown in the map "Dock Viewing Area".
- **5.** The limits of "The Avenue" car park, Woodbridge is amended. Its location and extent are shown in the map "The Avenue".
- **6.** Schedule 1 to the 2008 Order (as varied by the 2010, 2012, 2013 and 2015 Variations) is replaced by Schedule 1 to this Order.

The following variations have been made to Schedule 1:

- 1. The car park known as "Leisure Centre Forecourt" in Felixstowe is deleted.
- 2. Resident season ticket discount column is deleted.
- 3. The car parks called "Dock Viewing Area", "Landguard 1", Landguard 2", "Landguard 3" and "Landguard 4" are amended from tariff code 3 (free) to tariff code 22 (P&D).
- 4. The car park called "Slaughden Road" is amended from tariff code 3 (free) to tariff code 1 (P&D).

- 5. Wickham Market railway station car park, Campsea Ashe is added to the order with tariff code 3 (free). Its location and extent are shown in the map "Campsea Ashe Station Parking".
- 6. Hamlin Road extension car park (Woodbridge Co-Op) Woodbridge is added to the order with tariff code 20. Its location and extent are shown in the map "Hamlin Road Extension".
- 7. The car park called "Darsham Station West" is added with tariff code 23. Multi-day tickets to be available from the ticket machine. Charged days: MTWTFS; chargeable hours 08:00-18:00. Its location and extent are shown in the map "Darsham Station West".
- 8. The car park called "Darsham Station East" is added with tariff code 23. Multi-day tickets to be available from the ticket machine. Charged days: MTWTFS; chargeable hours 08:00-18:00. Its location and extent are shown in the map "Darsham Station East".
- Bawdsey Quay Picnic Site is amended from tariff code 3 (free) to tariff code 24 (P&D).
- 10. Felixstowe Ranelagh Road and Saxmundham Market Place car parks are changed from tariff 10 to 11.
- **7.** Schedule 2 to the 2008 Order (as varied by the 2010, 2012, 2013 and 2015 Variations) is replaced by Schedule 2 to this Order.

As well as tariff price increases, the following variations have been made to Schedule 2:

1. Season Ticket prices are increased:

- 2. Tariff code 11 is added at £1 for 1 hour, £1.20 for 2 hours, £1.40 for 4 hours and £2.30 for 4+ hours.
- 3. Tariff code 22 is added at free for the first hour, £1 for 2 hours, £1.50 for 4 hours and £4 for 4+ hours.
- 4. Tariff code 23 is added at £1 for up to 4 hours; £2 for 4+ hours.
- 5. Tariff code 24 is added at £1 for up to 2 hours; £1.50 for up to 3 hours; £3 for up to 4 hours and £4 for 4+ hours.
