NOTICE OF VARIATION given under sections 35C and 46A of the ROAD TRAFFIC REGULATION ACT 1984 - EAST SUFFOLK COUNCIL (OFF-STREET PARKING PLACES) ORDER 2020

NOTICE is hereby given that East Suffolk Council intends to, not less than twenty-one days from the date of this notice, vary the above Order relating to charges (fees) at its off-street parking places under Section 35C and 46A of the Road Traffic Regulation Act 1984. It is intended that the changes will take place on 4 December 2020.

The variation will have the effect of changing the tariff of charges (shown inclusive of VAT at the prevailing rate) at the locations tabled below. All other locations will continue at their existing tariffs. All the charges shown are gross with VAT included at prevailing rate of 20%.
