**THE SUFFOLK COASTAL DISTRICT COUNCIL (OFF-STREET PARKING PLACES)
(VARIATION) ORDER 2015**

NOTICE OF MAKING ORDER

1. TAKE NOTICE that SUFFOLK COASTAL DISTRICT COUNCIL ("the Council") of Council Offices, Melton Hill, Woodbridge, Suffolk, IP12 1AU has made the Suffolk Coastal District Council (Off-Street Parking Places) (Variation) Order 2015 ("the Order").

2. The purpose of the Order is to amend provisions of the Suffolk Coastal District Council (Off-Street Parking Places) Order 2008 as varied by the Suffolk Coastal District Council (Off-Street Parking Places) (Variation) Orders 2010, 2012, 2013 and 2013#2 which apply to all the off-street car parks operated by the Council. Save as varied by the Order the Suffolk Coastal District Council (Off-Street Parking Places) Order 2008 as varied by the Suffolk Coastal District Council (Off-Street Parking Places) (Variation) Orders 2010, 2012, 2013 and 2013#2 will continue to apply.

3. Variation is:

1. The car park known as "The Elms" in Framlingham is deleted.
2. Management of the car parks in Wickham Market is altered:
 - a. Chapel Lane: short-stay charges are introduced (tariff code changed from 3 to 21). Six dedicated spaces are reserved for the Doctors and one each for the Library and Resource Centre. Residents of the Flagship supported housing who have vehicles are issued with free permits.
 - b. Tariff code 21 is added set to free for the first hour and £1 for up to 2 hours.
 - c. Tariff code 15 is changed to free for the first half hour and £1 for up to 2 hours.
 - d. Tariff code 14 is changed to free for the first hour, £1 for 4 hours and £1.50 for 4+ hours.
 - e. A monthly £10 season ticket is added, valid in The Hill long-stay car park only, available to buy from local designated outlets.
 - f. The Village Hall car park is added, remaining free (tariff code 3).
 - g. The charging times are changed back to the standard 8:00-18:00.
3. Tariff code 1 is amended by the addition of a 1 hour period at the price of £1.
4. The car park "Felixstowe Leisure Centre Extension" is added with tariff code 8.

4. The Order will come into force on the 8th day of June 2015.

5. If any person wishes to question the validity of the Order or of any of its provisions on the ground that it is or they are not within the powers contained within the Road Traffic Regulation Act 1984 as amended, or that any requirement of the Act or of any instrument made under the Act has not been complied with that person may, within six weeks from the date on which the Order is made, apply for the purpose to the High Court.
