

<p>Introduction</p>	<p>East Suffolk Economic Development and Economic Regeneration Team have provided this privacy notice to help you understand how we collect, use and protect your information whilst we provide you with Economic Development, Regeneration, Funding and Felixstowe Forward Services.</p> <p>The document below will describe how we may collect and process your personal information.</p> <p>The purpose of this document is to clearly acknowledge the councils' responsibilities in relation to the General Data Protection Regulation (GDPR) and the Data Protection Act 2018.</p>
<p>Definitions</p>	<p><b>Personal Data</b> means any information related to an identified or identifiable natural (living) person ('<b>data subject</b>') i.e. a person that can be directly or indirectly identified by reference to a name, ID reference number, email address, location data, or physical, physiological, genetic, mental, economic, cultural or societal identifier</p> <p><b>Special Personal Data</b> previously known as 'sensitive personal data', relates to race, ethnic origin, politics, religion, trade union membership, genetic data, biometric data, health, sex life or sexual orientation. Records of criminal personal data must also be treated in a similar way.</p> <p><b>Data Controller</b> determines the purposes and means of processing personal data.</p> <p><b>Data Processor</b> is responsible for any operation which is performed on personal data on behalf of the controller e.g. collection, recording, organisation, structuring, storage, adaption or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or making available, alignment or combination, restriction, erasure or destruction.</p> <p><b>Third Party</b> is someone / somebody who is not the Data Controller, the Data Processor or the Data Subject.</p>
<p>Who we are</p>	<p>East Suffolk Council's Economic Development and Regeneration team reinvigorate the local economy through physical regeneration whilst enhancing the local environment to support economic growth and prosperity. How the law protects you	<p>GDPR says that we are allowed to use personal information only if we have a proper reason to do so. More information on how the law protects you can be found on the <a href="#">East Suffolk website</a>.</p>
Our Responsibilities	<p>GDPR provides us with main responsibilities for processing personal data.</p> <p>All personal information provided by you is held securely and in confidence by us in our computerised and other records. Your Rights	<p>The GDPR provides you with the following rights:</p> <ol style="list-style-type: none"> <li>1. The right to be informed</li> <li>2. The right of access</li> <li>3. The right to rectification</li> <li>4. The right to erasure</li> <li>5. The right to restrict processing</li> <li>6. The right to data portability</li> <li>7. The right to object</li> <li>8. Rights in relation to automated decision making</li> <li>9. The right to withdraw consent</li> <li>10. 	<p>Development and Regeneration Teams</p> <ul style="list-style-type: none"> <li>To send information to you that we believe will be in your interest</li> </ul> <p>We will not use your personal data for other purposes other than for what it was collated unless we have obtained your consent or for other lawful purposes (e.g. detection and prevention of fraud).</p> <p>We do not use systems to make automated decisions about you.</p>
How long do we keep your information?	<p>We will hold your personal information in line with the Council's Retention Policy:</p> <ul style="list-style-type: none"> <li><b>Financial Data – 6 years plus current</b> or longer if required by grant/financial regulation (when providing financial data you will be informed if your data is to be held longer than the time stipulated above)</li> <li><b>Personal Data – 3 years plus current</b> for inactive data or longer if required by contractual or legislative regulations (when providing personal data you will be informed if your data is to be held longer than the time stipulated above)</li> </ul> <p>You can request that your personal information is deleted at any time.</p>
Data Sharing	<p>We will share your personal information with:</p> <ul style="list-style-type: none"> <li><b>Event application information</b> shared on a <b>consensual</b> basis with Event Consultation Groups, to ensure the Health and Safety integrity of events that are run on the East Suffolk Councils' Land</li> <li><b>Consultation responses information</b> shared on a <b>consensual</b> basis with Project Consultation Delivery Partners, to allow members of the public to express their view's on particular projects</li> <li><b>Business enquiry and support requests</b> shared on a <b>consensual</b> basis with partner organisations to assist with aiding business enquiries and support requests</li> <li><b>Grant Application data</b> shared on a <b>consensual</b> basis with grant application providers as requirement for achieving grant funding</li> <li><b>Project Evaluation Data</b>, shared on a <b>consensual</b> basis with project evaluators to assess the success of that project</li> <li><b>Contact information</b> shared on a <b>consensual</b> basis with third party mailing software companies, such as Mail Chimp, to allow for easy circulation of information from East Suffolk Economic Development and Regeneration team that would be of interest to the individual</li> </ul>
Transferring your information overseas	<p>Currently, we do not transfer any personal information outside of the European Economic Area (EEA).</p>
National Fraud Initiative (NFI)	<p>We may share information provided to us with other bodies responsible for auditing, or administering public funds, or where undertaking a public function, in order to prevent and detect fraud.
