# DECISIONS BY THE CABINET CALL IN DEADLINE 5.00 PM ON 11 OCTOBER 2018

Report Title / Ref No: Felixstowe South Seafront Regeneration Project – Application to Coastal Communities Fund (CAB 35/18)

## **Decision Made by Cabinet:**

- (1) That the intention to submit an application to the second stage round of the Coastal Communities Fund for a grant of £950,000 for the Felixstowe South Seafront Regeneration Project be noted, and that it be recommended to Council that the submission be made, subject to successful feedback from Stage 1.
- (2) That Council be recommended to give approval for delegated authority to the Strategic Director, in the event of the bid being successful, to accept the grant, should it be successful, and agree to the terms and conditions of a contract, in consultation with the Cabinet Member for Economic Development.

**Reason for Decision:** The proposal will add substantially to the regeneration of part of Felixstowe Seafront which requires public investment for economic growth. It will help to make Felixstowe a more attractive destination and significantly add to the resort's visitor economy. The proposal will also generate jobs, with a direct economic benefit and it will also provide indirect benefits to the area through greater footfall along the South Seafront by acting as a destination complementing the recent Pier and Historic Garden destination investment.

Report Title / Ref No: Community Infrastructure Levy Spend Report (CAB 36/18)

# **Decision Made by Cabinet:**

- (1) That the Infrastructure Plan included at Appendix 1 to report CAB 36/18 be endorsed.
- (2) That the releasing of £1,201,200 of Community Infrastructure Levy monies to enable the undertaking of 8 no. projects as detailed within the report be agreed.
- (3) That the remaining funds (£1,199,716.10) should be banked for use in future years. This will enable more funding to be available for projects in the future when they are ready to be delivered.

#### **Reason for Decision:**

All projects recommended for CIL spend have indicated an identified need for the project in the local and/or surrounding area. Some projects have been supported by Suffolk County Council or local stakeholders, which has further reinforced their need for CIL funding. The majority of projects are located in areas projected to have increased housing growth in the coming years, apart from the Deben Estuary flood defence project which is justified based on its tourism, amenity and natural capital importance. Match funding has been identified for each recommended project. Some projects have involved substantial fund raising efforts which demonstrate a level of support for the project. Each project will be expected to meet a number of conditions of payment before the releasing of CIL funds. These conditions have been created in line with best practice and have been put in place to ensure the best value for money and to provide greater certainty to the Council. Some projects have been submitted with a large amount of detailed supporting evidence which has added to the certainty of the project coming to fruition.
