Report Title / Ref No: Web Casting of Council Meetings (CAB 19/18)

**Decision Made by Cabinet:** 

That approval be given to the implementation of a web casting system at East Suffolk House.

**Reason for Decision:** The implementation of a web casting service will support increased public engagement and awareness of the Council's work and decision making; it will also provide enhanced collaborative working facilities between East Suffolk House and Riverside.

- (3) That an advance of £70k from the transformation budget to 2018/19 ICT revenue budget be approved.

**Reason for Decision:** The changes to the funding arrangements will allow the implementation of the ICT Desktop Refresh project to be brought forward to July 2018 and thereby reduce risk to the successful delivery of the project.
