DECISIONS BY THE CABINET CALL IN DEADLINE 5.00 PM ON 13 APRIL 2017

The following decisions have been taken by the Cabinet and will come into effect on 14 April 2017 unless the call-in procedure is activated:

Report Title / Ref No: Suffolk Sport – Extension to Inter Authority Consortium Agreement (CAB 17/17)

Decision Made by Cabinet:

- 1. That the Head of Operations, in consultation with the Head of Legal and Democratic Services, be authorised to enter into a new Consortium Agreement with the other seven Suffolk local authorities on terms that protect the Council's interests.
- 2. That the Council, as Lead Authority for the Suffolk Sport consortium, continues to secure and administer all funding for Suffolk Sport.
- 3. That the Council's financial contribution of £3,840 for the financial year 2017/18 be authorised and the contributions for 2018/19 and 2019/20 set out in paragraph 4.3 of report CAB 17/17 be agreed in principle but these being subject to any future annual budget setting process.

Reason for Decision: Within the current policy context for community sport, County Sports Partnerships are highlighted as having a key role ongoing national core funding has been committed to the CSP Network by Sport England up until 2021 to support local strategic coordination and the delivery of national priorities locally. The strength of Suffolk Sport over the last 16 years has been the collaborative working with partners, particularly local authorities. The benefits to the district of the Council being a formal funding partner of Suffolk Sport include additional finance to sport locally but also significant support for participants, clubs, coaches and volunteers across the local area.

Alternative Options Considered and Rejected: Consideration has been given to withdrawing from the Consortium Agreement and to further reductions in the Council's financial contribution beyond the reduction proposed. Neither of these options were considered the most appropriate way forward for the Council at this time.
