**DECISIONS BY THE CABINET

Report Title / Ref No: Landguard Partnership: Extension to Agreement (CAB 09/18)

Decision Made by Cabinet:

- (1) That Suffolk Coastal District Council agrees to the proposal to renew the terms of the agreement for a further five years, subject to the agreement of all the members of the Landguard Partnership.
- (2) That Suffolk Coastal District Council continues making an annual contribution of £18,000 for a further four years, from 2018/19 to 2021/22, towards the Partnership's operational costs and to meet Suffolk Coastal District Council's objectives regarding its landholdings at Landguard.

Reason for Decision: The Landguard Partnership has created a synergy which has been successful in bringing stakeholders together to find achievable solutions whilst visitor numbers have increased exponentially. Without the Partnership organisations are more likely to focus on their individual aims to the detriment of the whole. The Council is critical in providing the stability and administrative support essential to the Partnership's successful continuation.

Alternative Options Considered and Rejected: To not support the continuance of the Landguard Partnership.
