**The following decisions have been taken by a Cabinet Member and will come into effect on 30 November 2018 unless the call-in procedure is activated:**

**Title: Approval of recommendation from the Enabling Communities Exemplar Grant panel members held via written procedures on 20 November 2018.**

**Decision Made by Cabinet Member with responsibility for Customers, Communities & Leisure:**

That the following applications in respect of applications for Enabling Communities Exemplar Programme be determined as follows:

Seckford Foundation – Approved - £9,429.60

Access Community Trust – Approved - £9,984 – on condition that they publicise the project with other groups (Job Centre, CABs) to ensure wider community is informed; understands that this is a one off payment from Suffolk Coastal District Council and the Group cannot come back for repeat funding; provide a clear timeframe (start and finish date); consider adding lone parents to their groups in future).

Sutton Recreation Ground and Memorial Hall Trust – Approved - £5,500 – on condition that Suffolk Coastal District Council is acknowledged.

Peninsula Villages Communities Land Trust – Approved - £6,750, subject to following conditions: the six parishes need to meet and discuss how these are funded in the future; the project needs to be publicised well and that the questions in the survey are simple and in plain English, also to ensure they provide examples to some of the questions; Why isn't Community Access Trust the main applicant?; the project provides a clearer budget sheet.

**Reason for Decision:** The agreed allocation of grant aid is the most effective and efficient use of the funds available and is in accordance with the criteria of the Enabling Communities Exemplar Programme.

**Alternative Options Considered and Rejected:** To not award the grant.
