Title: Direct Award of Contract – Provision of Domestic Abuse Specialist Advice and Support Service

## **Decision Made by Strategic Director:**

That a direct contract for the provision of Domestic Abuse Specialist Advice and Support Service be awarded to Anglia Care Trust in the sum of £89,504.00 on terms that best protect the Council's interests.

**Reason for Decision:** To ensure that the Department of Communities and Local Government grant is utilised to assist vulnerable households in Suffolk Coastal and Ipswich to assess appropriate specialist advice and support.

Alternative Options Considered and Rejected: Suffolk County Council devolved the funding to district and borough level for procurement purposes. The funding will also enable both councils to meet their new and additional duties under the Homeless Reduction Act 2017 whereby a number of groups that are vulnerable to homelessness are offered a tailored package of advice and assistance. The required pathway plan for victims of domestic abuse will be designed with the use of the above provision.

Title: Direct Award of Contract – Provision of Domestic Abuse Satellite Accommodation and Associated Tenancy Support

**Decision Made by Strategic Director:** 

That a direct contract for the provision of Domestic Abuse Satellite Accommodation and Tenancy Related Support be awarded to Anglia Care Trust in the sum of £109,996.00 on terms that protect the Council's interests.

**Reason for Decision:** To ensure that the Department of Communities and Local Government grant is utilised to assist vulnerable households in Suffolk Coastal and Ipswich to assess appropriate and safe accommodation. Suffolk Coastal District Council does not have any refuge accommodation in the district.
