DECISIONS BY THE CABINET CALL IN DEADLINE 5.00 PM ON 11 JANUARY 2018

The following decisions have been taken by the Cabinet and will come into effect on 12 January 2018 unless the call-in procedure is activated:

Report Title / Ref No: Response to Second Stage Consultation on the future management of off-street Car Parks in preparation for Civil Parking Enforcement, and next steps (CAB 01/18)

Decision Made by Cabinet:

- (1) That the price of season tickets be adjusted, as follows:
 - (a) Long-stay three months From £80 to £90
 - (b) Long-stay annual From £200 to £240
 - (c) Short-stay three months From £130 to £150
 - (d) Short-stay annual From £350 to £400
 - (e) Weekend recreational From £50 to £100
- (2) That Resident Off-Street Season Ticket Discounts be discontinued
- (3) That applications for Special Filming Permits be enabled
- (4) That individual town car park season tickets be enabled
- (5) That the possibility of the introduction of Resident Parking Zones, where requested by the community and where feasible, be investigated
- (6) That, with regard to <u>Felixstowe</u>:
 - (a) Tariff charges as set out in Appendix B to CAB 01/18 be implemented
 - (b) Pay and Display tariffs at Landguard be implemented
 - (c) The map of the Dock Viewing Car Park be updated to reflect the additional land in the 2013 lease

- (d) The Leisure Centre Forecourt be removed from the Order (to reflect the change of parking provision following the redevelopment of the Pier)
- (7) That, with regard to <u>Woodbridge</u>:
 - (a) Tariff charges as set out in Appendix B to CAB 01/18 be implemented
 - (b) The piece of land at The Avenue be redeveloped for additional parking provision at Station Road and The Avenue
 - (c) The benchmarking of long stay parking rates in Woodbridge be undertaken to reduce unintended and unnecessary road traffic
 - (d) The Hamblin Road Co-Operative car park be added to the Order to enable parking enforcement to be carried out on behalf of the Co-Operative
- (8) That, with regard to <u>Aldeburgh</u>:
 - (a) Tariff charges as set out in Appendix B to CAB 01/18 be implemented
 - (b) Pay and Display tariffs at Slaughden Road be implemented at the same level as those in place at Fort Green and Thorpe Road
- (9) That, with regard to <u>Wickham Market</u>:
 - (a) An additional new car park be investigated
 - (b) Signage to be reviewed and updated
 - (c) The eligibility of residents of Richard Kitson Court for free parking Permits to be reviewed

(10) That, with regard to <u>Saxmundham</u>, tariff charges as set out in Appendix B of CAB 01/18 be implemented

(11) That, with regard to <u>Campsea Ashe</u>, Wickham Market railway station's car park be added to the Order to enable parking enforcement of a maximum stay limit of 36 hours

(12) That, with regard to <u>Darsham</u>, Darsham Railway Station 'West' and Darsham Railway Station 'East' be added to the Order

(13) That, with regard to <u>Bawdsey</u>, the Bawdsey Amenity Site be added to the Order (with the intention that charges be introduced once management improvements for on-road parking and modest, environmentally friendly improvements to the car park, had been carried out)

Reason for Decision: In anticipation of parking enforcement transferring from the Police to Suffolk local authorities, off street parking places orders need to be prepared in readiness when the legal framework changes from the Road Traffic Regulation Act 1984 to the Traffic Management Act 2004.

Alternative Options Considered and Rejected: None.

Any Declarations of Interest declared: Councillor Smith declared Local Non Pecuniary Interests as a member of Felixstowe Town Council and also as Chairman of the Landguard Partnership.

Any Dispensation Granted: None.

Report Title / Ref No: Amendment to Renovation Grant Policy – Introduction of Warm Homes Grants (CAB 02/18)

Decision Made by Cabinet:

(1) That Warm Homes Grants be introduced and the Council's existing grants policy be amended

(2) That delegated authority be given to the Head of Housing to approve the award of Warm Homes Grants in accordance with the eligibility criteria and report (CAB 02/18)

Reason for Decision: To secure the alleviation of cold, unhealthy living conditions in homes occupied by fuel poor households in a timely manner.

Alternative Options Considered and Rejected: None

Report Title / Ref No: Local Council Tax Reduction Scheme for 2018/19 (CAB 03/18)

Decision Made by Cabinet:

- (1) That the following be recommended to Full Council for approval with effect from 1 April 2018:
 - (a) The Local Council Tax Reduction Scheme to continue to pay maximum benefit of 91.5% for working age claimants with the remaining 8.5% paid by the individual(s)
 - (b) Benefit rates, known as applicable amounts, be uprated to 2015 rates
 - (c) The Local Council Tax Reduction Scheme be harmonised with the Department of Work and Pensions Welfare Reforms introduced by the Prescribed Scheme for Pensioners and Housing Benefit

(2) That, once Suffolk Coastal District Council had entered the Full Universal Credit Service, the introduction of links to the award of Universal Credit for entitlement to the Council's Local Council Tax Reduction Scheme (so removing the requirement for a separate application) be recommended for approval by Full Council

Reason for Decision: The consideration of an annual review and potential proposed changes to the Scheme is a statutory requirement under the Local Government Finance Act 2012

Alternative Options Considered and Rejected:

- Restricting maximum Council Tax band used to assess entitlement to Band D effects 65 individuals at a council tax income gain of £22,558.
- 2. Restricting savings cap from £16,000 to £6,000 effects 57 individuals whom are likely

to requalify once their savings reduce at a council tax income gain of £42,566.

3. Increasing customer contribution rate to more than 8.5% – the possible increase in Council Tax collected for the Council is considered to be less than the additional costs of recovery
