**Interest 3** - Any beneficial interest in securities of a body where:

- (1) that body (to your knowledge) has a place of business or land in the area of the Council; and
- (2) either-
  - (a) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
  - (b) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issue share capital of that class.

**Interest 4** - A contract for goods, services or works made between the relevant party and the Council (or a body in which a relevant person has a beneficial interest) under which goods or services are to be provided or works are to be executed, and which has not been fully discharged.
