Purpose of Report

To seek approval to appoint a temporary Project Officer in order to ensure that all of the relevant changes to policy and Service Level Agreements, with partners such as Suffolk County Council, are delivered in advance of the project implementation date, from May 2019 onwards. The role will be essential in delivering the project in a way that will minimise the costs of delivering Civil Parking Enforcement for both Suffolk Coastal District Council and Waveney District Council.

Options Considered

The option to manage the Civil Parking Enforcement programme via current resources has been discounted, having explored the staff time available at WDC, SCDC and both Norse partnerships.

Reason for Decision

To ensure that the implementation of Civil Parking Enforcement in the District is adequately resourced and delivered.
