Self-Isolation Payment Eligibility Guidance

Am I eligible for a payment?

NHS Test and Trace Criteria

Main payment

- Have you tested positive for Covid-19 and been contacted by NHS Test and Trace and been told to self-isolate? Or
- From 30.11.2021, are you suspected or confirmed as a contact of someone with the Omicron variant and been told by NHS Test and Trace to self-isolate? Or
- From 16.08.2021, are you over 18yrs and have you been in contact with someone who has tested positive for Covid-19 and you are not double vaccinated?
- Do you have a valid NHS Test and Trace reference number?
- Have you responded to your notification from NHS Test and Trace and engaged by providing the legally required information?

Or

Parent/guardian payment

- Are you the parent or guardian of a child (under 15yrs) who has tested positive for Covid-19?
 Or
- Are you the parent or guardian of a child who is a contact of someone suspected or confirmed to have the Omicron variant?
 Or
- Are you the parent or guardian of a child (aged 18-25) with an education health plan, who has tested positive for Covid-19 or is a contact of someone who has tested positive?

AND

Main payment Work Status Criteria

- Are you employed or self-employed?
- Are you unable to work from home? (This must be specifically due to self-isolating and not because you were already unable to work due to lockdown restrictions)
- Will you lose income as a result of not being able to work from home? (You must be
 expecting a reduction in your income while you are self-isolating maybe you will only
 receive SSP or will lose out on overtime/additional hours or maybe you are self employed
 and won't receive any income at all)

If you answer Yes to <u>all</u> questions above, you may be eligible for a payment if you fit either of the additional criteria below:

ARE YOU EITHER?

- In receipt of one of these benefits?
 - o Universal Credit

- Working Tax Credit
- o Income-based Job Seekers Allowance
- Income-related Employment and Support Allowance
- Income Support
- Housing Benefit
- o Pension Credit

OR

- Is your income less than £57,400 (couple or single parents) or £39,200 (single person)?
- AND your capital below £10,000?

Siblings Discretionary Scheme

Do you have a child <u>aged 16 or over</u> who has tested positive and you are not eligible for a Government Test and Trace payment (detailed above) and the child has a sibling aged under 16 who has also been asked to self-isolate?

- You must fulfil all other Test & Trace criteria (unable to work from home, will have a loss of earnings etc)
- o Your positive child is over 16
- o The sibling self-isolating is under 16

A discretionary payment of £500 will be considered if the sibling later tests positive OR £150 if after 3 days the sibling tests negative and returns to the educational establishment

** You must make your claim within 42 days of the start of your Self-Isolation period.

EVIDENCE AND INFORMATION:

To make your application you will need:

- Your National Insurance Number
- Your unique 8-digit Test and Trace reference number
- Proof of employment or self-employment
- A bank statement showing your address
