The SGPB is chaired by Stephen Baker, Chief Executive of East Suffolk Councils with membership drawn from Suffolk Local Authorities; New Anglia LEP; the University of Suffolk and Suffolk Chamber of Commerce.

Role

The role of the Growth Programme Board, as agreed in December 2016, is to:

iv. manage risk: by understanding upcoming risks / unknowns and responding to these through a flexible & innovative approach to economic growth

Suffolk's Framework for Growth

The Framework for Growth was agreed by the Suffolk Growth Portfolio Holders and Public Sector Leaders in January. The Framework brings together the shared growth work that is being taken forward by across Suffolk into a single, cohesive programme. The Framework:

> (i) Presents our starting point and ambitions to allow us to engage with communities, partners and Government with a clear and consistent message

> (ii) Sets out a single, concise summary of the work being taken forward to plan, coordinate and deliver growth across Suffolk

(iii) Enables connections between programmes of work across the public sector, thereby minimising duplication and ensuring greater benefit is delivered through our investments

It builds on our conversations with Government, our partners and our communities, which started with our proposals for devolution and have been built on through our responses to both the Industrial Strategy and the Housing White Paper. The Framework provides the mechanism for monitoring our successes and realigning work to not better meet our shared growth outcomes.

The FRAMEWORK FOR GROWTH is coordinated through the Suffolk Growth Portfolio Holders (GP/H) and will continue to be taken forward by the Suffolk Growth Programme Board (SGPB). It is through this partnership approach that we will be able to deliver our ambitions. It will continue to be reviewed and updated as projects are developed and as our shared growth agenda is delivered.

Suffolk Design!



Since the March newsletter, 4 more Suffolk Design events have been held. These events were:

Study tour 3 - Essex!

Monday, 11th March 2019

The third Study Tour took place on Monday, 11th March 2019. A total of 18 Local Authority staff, 5 Councillors and 5 designers attended and 4 sites were visited: Brentwood School, The Echoes in Grays, St Chads in Tilbury and Bracelet Close in Corringham.

Masterclass 2 - Tools of Proactive Planning Thursday, 27th March 2019

This 2nd masterclass focused on a continued dialogue from the first masterclass: what it means to practice 'proactive planning', to develop a detailed understanding of the relevant tools,

such as policy documents, codes and guides, councilled initiatives, design commissions and briefs, land assembly powers, participatory exercises, design charrettes, and masterplans. The considerations for, and value of, each tool was explored by those involved both in using, preparing and commissioning these tools.19 Local Authority staff, 3 Architects and 2 Developers attended this event.

Masterclass 3 - Context Sensitive Design

Thursday, 4th April 2019

This event explored how good design can be nurtured within a sensitive context, be it a historic, rural, or a urban place looking to grow. Sensitive and responsive design is rooted in a deep understanding of the established condition and historic context, balanced with future aspiration -the class sought to seek to build an understanding of what sort of studies, analysis and research underpin this effort, as well as how this iterative, non-linear process is best captured in the planning system.

23 Local Authority staff, 3 Architects and 3 Developers attended this event.



Masterclass 4 - The Environment and landscape in design

Monday, 29th April 2019

The final event in our series of masterclasses looked at the way landscape and the wider environment influence design. It included presentations on environmentally sensitive design, developing landscape frameworks and integrating water into our places. A total of 25 LA staff, 1 Cllr and 3 developers attended the event.

Next Steps for Suffolk Design! -

The initial Suffolk Design event programme is now complete and the first step in developing and embedding a new approach to design and community engagement across the planning system. Moving forward the project team for Suffolk Design is shaping a protocol and design management process that will be agreed with all local Planning Authorities. This process will then be developed through an IT platform allowing for greater consistency and a shared approach to engagement with landowners, developers, statutory consultees and our communities.

Public Sector Procurement!

SGPB has been working with Procurement Leads across the public sector to better understand how local procurement can impact on the local economy. In summary our work has:

- Mapped 2017 spend across 12 partner organisations looking at volume, value and sector. We identified a total of £1.9bn spent by the organisations with 53% of this spend going to an organisation based in Suffolk.
- Delievered 6 "Fit to Bid" training sessions supporting 106 individuals from SMEs have taken part in the "Fit to Bid" training across 6 events held in Lowestoft, Bury St Edmunds, Ipswich, Stowmarket, Haverhill and Woodbridge for 2019 (see calendar of events). To see the feedback from all of the events <u>click here!</u> Following an internal review of the training, it has been decided that further training events will be organised to take place over 2019/20. The SGPB will be organising these events jointly with the Suffolk Chamber of Commerce.
- Established the SGPB Procurement Leads group looking at sharing best practice and, where appropriate, developing shared approaches / joint training. The SGPB are looking to run a Social Value shop in association with the LGA and private sector social value leads. Look out for more info!
- Greater engagement with private sector developers / Tier 1s on major projects across Suffolk - e.g:
 - Supporting supply chain days such as KVF35 Lakenheath and Vattenfall Offshore supply chain events.
 - Discussions with social value leads at Kier and Morgan Sindall to better understand their local impact.

A total of 528 people have attended 20 events – including LA staff, Cllrs, stakeholders, designers and developers!

Skills & Employment!

In the last edition of our newsletter we announced that SGPB is working with the skills team from SCC to map the demand for and supply of the technical skills required in Suffolk over the next 10 - 15 year period with a specific focus on the construction roles required for key infrastructure development projects. We are happy to announce that Norfolk County Council has joined us in this commission and together we have appointed Pye Tait Consultants to carry out this work. An extract from the brief is given below:

To meet our long-term growth ambitions Suffolk businesses must have access to a sufficient volume of the technical skills that significant infrastructure developments will require. In order to best ensure that this demand is met we require a comprehensive, current assessment of these technical roles and both the foundation skillsets and the changing competencies that will be required to fulfil them - at both an absolute level and with a more detailed breakdown of the higher skilled, higher wage, roles.

This will help ensure we drive local employment, training and upskilling in the technical skills that are currently in demand and that have likely applications in future infrastructure development (i.e. a 'legacy' skillset), thus mitigating against the risk of training for unemployment.

Level 3 Planning Apprentices!

Following the successful programme implemented with TCA funding in 2016. The SGPB is working with both HR Leads and the Heads of Planning from across Suffolk, to recruit up to 10 Level 3 Planning apprentices that will be partly funded through the SGPB.

The SGPB are designing an interactive recruitment brochure, to ensure that as many people young people as possible apply for the positions! We are targeting recruitment for July / August with appointments confirmed in September in time for an October start at Chichester College. Additional group training sessions will be developed with the Heads of Planning, in order to allow the cohort of apprentices to support one another through peer support! 50% of the Level 3 Planning apprentices from 2016 have gone on to start their Level 4 qualification!



Major Sites Forum!

The SGPB have set up a Major Sites Forum that meet for the first time on 1st May 2019. The Forum will consist of Senior Planning Officers that work on large / major sites, from across all of the Suffolk LA's (including SCC Highways / Floods teams).

The aim of the Forum is to learn from best practice and to report learning back to their Planning teams. The Forum will also support Suffolk Design by providing exemplar sites that can be used as part of design guide.

The group have agreed to meet on a 8 weekly basis, and have a wide range of agenda topics for future meetings!

Screen Suffolk!

SGPB is supporting Screen Suffolk as they develop a business case to examine options for developing a production fund and an initial report is due later this year.

The SGPB will Influence...

The SGPB are committed to influencing the growth priorities through engagement. The following shows some of the meetings, organisations, consultations and forums where we currently engage.

Economic Strategy Delivery Coordinating Board!

Both the Chair and the SGPB Partnership manager are on the ESDCB, with responsibility for coordinating and overseeing the delivery of Norfolk and Suffolk Economic Strategy. This Board is also supporting NALEP in the development of our Local Industrial Strategy.

The SGPB are supporting the work of the ESDCB and have set up a LIS Task & Finish Group. This is a small group of members from throughout the Suffolk LA's that are currently on the SGPB. The LIS Task & Finish Group will meet every 3 weeks.

Transport East!

Transport East is the emerging Sub-national Transport Board (STB) for this region. Attended by members from both County and District level, the SGPB provides input to the Senior Officer Group and member support at Forum meetings.

Water Resources East!

Water Resources East (WRE) is a newly established private / public sector partnership (as a company limited by guarantee) to lead on the development of a single multi-sector Regional Plan for water for Eastern England.

SGPB, in partnership with Suffolk County Council, Norfolk County Council and NALEP is engaging with WRE as the partnership develops and is considering options for an enhanced role. A launch event is planned for 1st July and more details are available from <u>SGPB@eastsuffolk.gov.uk</u>

Brexit Task Force!

Brexit Task Force: Nick Khan (Strategic Director, East Suffolk Council) and Caroline Davison (Head of Policy, Suffolk County Council) are leading the Brexit Task Group. This is a small cross public sector task group of officers (including the SGPB partnership manager) to monitor the impacts of and coordinate Suffolk input to Government.

The SGPB project coordinator supports the weekly intelligence and research briefing leading on updates on funding opportunities, consultations and important information relating to growth. If anyone would like to receive these updates please contact Kay.
