
Active Travel in Suffolk

Government policy with the introduction of Gear Change and LTN1/20 in 2020

Establishment of Active Travel England

Greater focus on 'place' encouraging people to walk, wheel and cycle to replace short journey's usually undertaken by car

Greater emphasis on schools, both in terms of safety outside schools and looking at how children travel to school. First school street in Suffolk in Jan 2024, Giving children independence when travelling to school
