Now we're heading into autumn and the main growing season is over many of us will be thinking about clearing the spent growth from our gardens or allotments ready for the winter season.

While we're doing so it's a good time to remember the wildlife too; for example if you provide a bird nest box it's a good idea to take it down and clean it out with boiling water or give the birds a nice parasite-free place to raise next year's chicks. Once completely dry if you place a handful of clean hay (not straw) or wood shavings inside, small mammals might like to hibernate or small birds may roost inside. # Climate Emergency—what is East Suffolk Council doing about it?

James Mallinder explains

This summer East Suffolk Council declared a climate emergency. This combined with the declaration by Cllr Steve Gallant, leader of the Council, that the environment is to be one of the top priorities clearly illustrates that this new council will not only be responsive to residents' needs, but the needs of the environment. The environment is not just about the grass and trees we see through the window, but is also the jobs we do, the houses we buy and how we travel, the food we eat and the resources we consume – we all depend on a healthy environment for these things. Our environmental policy will be developed through the prism of our strategic plan, and will complement our economic policies.

As cabinet member of the Environment it is my ambition to be proactive and champion the nurturement and preservation of the environment but this has to be consistent with infrastructural works, house building and a strong economy for all stakeholders. Protecting the environment and promoting development are not a binary choice but must work together, for example by ensuring that we continue to deliver the services that our communities need but by using less of our planet's resources in doing so. As we adapt to a changing climate, we must seize the opportunity to reconsider the ways in which we do things and find better, cleaner, more environmentally friendly ways to ensure East Suffolk continues to be a great place to live, work in and visit.

As a direct response to the climate emergency, East Suffolk hasn't wasted any time in being proactive, and at our last cabinet meeting I presented a paper establishing our new Environmental Task Group . This will be cross party, meet regularly and will analyse the policies inherited from Suffolk Coastal and Waveney and importantly highlight issues that require further investigation in order to make recommendations to cabinet.

As well as big issues we will look at small changes in our working practices, as these small changes can, together, make a big difference. The Environment Task Group will on occasions be opened to all ward members and Council officers, especially when we have invited guest speakers and workshops, and will truly develop a Council-wide vision to ensure that our environment is respected and secure a better future for us all.

## Active & Sustainable Travel update

What have we been doing since the Active Travel Forum on World Environment Day 5th June? Taking on board the feedback from delegates we have requested some funding support from the East Suffolk Partnership to develop some projects to increase uptake of active and sustainable travel and are delighted that the ESP have indicated funding support for our project, in principle.

So what are we proposing?

- A recruitment drive calling for more volunteer drivers to improve the resilience of community transport schemes
- Work with schools to promote walking buses and deliver cycle tuition for pupils
- Establishment of more Quiet Lanes to make country roads more appealing to those wishing to travel by non-motorised means

In the coming months we will be collaborating with other organisations to develop more detail into these plans and will be contacting schools to gauge interest in the schools-related projects. ## Student Action litter pick at Lowestoft Sixth Form College!

On Wednesday the 26<sup>th</sup> of June, several green-fingered teens took part in a student-organised litter pick on an area, local to the college grounds, which had faced a significant amount of neglect for many years.

Supported by several staff that also expressed concern for the environmental quality of the area, the students set out to target the sheer amount of waste that had accumulated on the site. With help from the 'Love East Suffolk' scheme, equipment was borrowed from the council in order to carry out the litter-pick itself, something of which students were very

thankful for.

The site itself, upon initial inspection, was heavily littered with a mix of plastic, glass and even some newer eco-friendly materials!



Over the course of a few hours (and a few cups of tea), the students emerged from the walkway with 20 bags of rubbish and numerous miscellaneous items (as shown in the picture.) The most 'vintage' piece of litter found from the pick was a tin can from the 70's, yet several students were amazed to find items that were of similar age to themselves.

One student commented:

"The litter pick has really broadened my perspective about how we need to take care of the environment."

Organised via the Student Committee at the college, this was the first of many more eco-initiatives to come now that the academic year has recommenced.

In particular the students are starting to show concern towards the use of plastic cutlery in the college cafeteria, something of which is actively being campaigned against by the Student Committee.

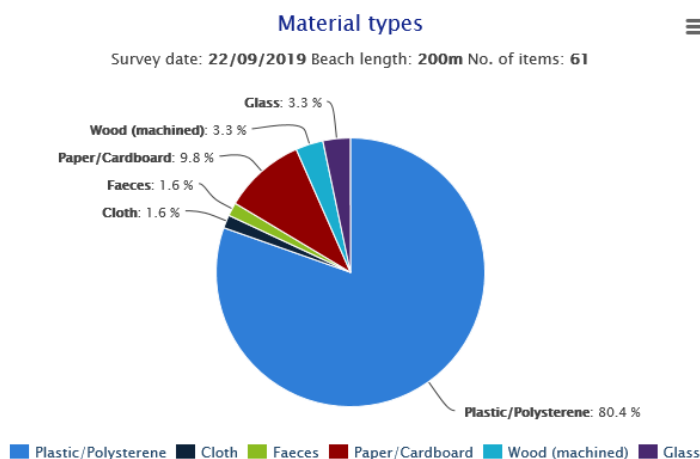

### Greenprint Beachwatch Event

A total of 11 of us turned out to clear and survey the marine litter on Southwold beach north of the pier on 22 September, including a family of seasoned Beachwatchers from Ipswich and an inspiring couple who were in Suffolk on holiday and who do a beach clean every time they have a holiday by the seaside.

We were pleased to see so little litter on our transect, in particular relatively few plastic fragments and no plastic pellets at all. If it had not been for a mass of tangled netting and rope—a significant hazard for marine wildlife—we would have removed much less than the **1.96KG** of litter gathered from the transect. ## First time central heating systems for Suffolk residents



Suffolk's local authorities have secured funding from National Grid's Warm Homes Fund to install over 700 first time central heating systems in eligible, fuel poor households across Suffolk by 2021.



Around four million UK households are in fuel poverty, unable to affordably heat their home to the temperature needed to stay warm and healthy. As well as being on low incomes many of these households are also faced with the additional burden of relying on heating systems that are inefficient and expensive to run.

The project has already installed over 200 systems. A resident who received a central heating system said:

*"Many thanks for all your help and enabling me to be warm this winter and in the future - without which I don't know what I would have done".*

## Community Buildings Advisory Service—now available East Suffolk-wide!

This service, previously only available in West Suffolk and the former district of Waveney, is now available across all of the new East Suffolk district.

- **Community Building Energy Audits:**

A free assessment of your building, identifying ways to cut your running costs and minimise your greenhouse gas emissions. Whether you've got refurbishment plans in mind or not, this audit can help you make an informed decision about the best future for your community space.

- **Help to upgrade your heating system:**

Worried about an unreliable boiler, or have expensive electric heaters that are good at warming your head but leave your feet in the cold? The service can help you find the right green heating option for your building, from air and ground source heat pumps to biomass, microCHP and condensing boilers.

- **Grants and Funding:**

The service can signpost you to the latest funding options and put you in touch with installers so you can obtain suitable quotes. Moreover, the savings identified in the audit can be useful evidence when making grants applications.

# Improving Council land for nature and wildlife

## James Mallinder explains

In less than 100 years we have lost 97% of our wild flower meadows in Britain. This has had a profound impact on our wildlife especially insects and pollinators.



The effects of climate change are not just seen in some far away country but are on our door step and we need to reverse some of the trends from our history. An important aspect of this is to increase the amount and quality of species-rich grassland.

We at East Suffolk are responsive to the needs of our residents and the environment and are pleased to be one of the first councils across the UK to commence this re-wilding. At our July full council meeting I presented a paper which gave me the authority to pilot such a scheme in the areas of Saxmundham and Southwold. We have collated a list of the land that East Suffolk manages and passed this to the respective town councils and in turn the town councils will consult with residents and stakeholders to see if they would like the grass cut less. It is as simple as that .

I do wish to emphasise that no cutting does not mean no maintenance - if land borders roads a narrow verge the grass will be cut to prevent obstructions to drivers. Also to involve the local community, the town councils will be asked to establish volunteer groups who will monitor litter and invasive species.



During this pilot period we will also look at less spraying and study alternative methods to weed killers across paths and round sign posts.

Less cutting of grass land not only increases insects, especially pollinators, but visually will look impressive and improve the wellbeing of residents engaging them with nature and will be a great example of how small changes can make a real difference over time.

## New Repair Café in Woodbridge!

On the first Monday of every month a repair café is held at The Hub community café at St Johns Church in Woodbridge. The project is a collaboration between St Johns Church and Transition Woodbridge who are also extremely grateful to Woodbridge & District Lions who funded the start-up costs and East Suffolk Council Communities for their recent funds which will help towards buying repair bits and pieces to enable volunteers to take on small repairs.

The project aims to repair small items such as hems on clothing, lamp switches, electrical items, bags, electronic items, etc so they remain in use instead of being binned, but

won't do repairs where there is capacity provided by local traders and will refer on jobs to local traders where appropriate so as not to compete, but rather to meet the need. The Repair Café runs from 10:00-12:00noon.



## Want to see a Community Fridge in your neighbourhood?

Community Fridges are places where surplus food is shared within a local community – by businesses and individuals. They help to reduce food waste and bring folk together around good, surplus food donated by local organisations and individuals, on an open-to-all-basis. There are 78 open in the UK at present and they exist in Community Centres, cafes, churches, such as Andrew's Church in Lowestoft which hosts Suffolk's first community fridge which was established earlier this year with the support of the Suffolk Waste Partnership, the district Council, the Morrisons Foundation, and environmental charity Hubbub. It is run by volunteers supported by the Community Enablers Team from Community Action Suffolk. The fridge was kindly donated by Hughes Electrical.

# Relaunch of Solar Together

## Group purchase scheme for domestic solar power



Considering solar power for your home but daunted by the task? Then the Suffolk Climate Change Partnership has good news for you!

Solar Together Suffolk can once again offer you savings on the installation of solar panels for your home. The scheme was a big success in 2018, with 635 households saving an average of 20% on the cost of a new solar panel array. It's a group-buying scheme that helps you through the process, keeping you informed at every stage.

If you are interested in saving money on your energy bills and helping the environment by reducing your carbon emissions - register today. Registration is free and no-obligation. The more people who register by the deadline of 21 October, the better the price that can be secured and the more clean energy will be generated by Suffolk residents. With solar panels, it is estimated the average household will reduce its annual carbon emissions by nearly one tonne each year - the equivalent of driving 3,200 miles in an average petrol car!
