Changes to Steering Group

Introduction from new ESC Sustainable Travel Officer, Aimee McLachlan

- Working with Katch and Buzzabout, currently operating in Lowestoft, Framlingham... with plans to expand to Hacheston.

- Leading cycling, walking, and wheeling projects to connect towns and parishes.
- Overseeing project management to ensure delivery of transport initiatives.
- Andrew Burgess operates Katch, which has now been extended to Rendlesham.

Overview of and discussion on Neighbourhood Planning document relating to climate change – Ruth Bishop

- Ruth provided an overview of the Neighbourhood Planning document currently open to public consultation.
- A range of support documents have been made available online, along with new guidance and consultation opportunities.
- Topics covered in Neighbourhood Plans include:
 - Housing
 - Employment
 - Design
 - Parking
 - Historic environment
 - Walking and cycling infrastructure
 - Allocating local green spaces
 - Identifying and protecting key views
 - Climate change, flooding, and coastal change
 - Infrastructure priorities

Benefits of a Neighbourhood Plan

- With a plan: Receives 25% of Community Infrastructure Levy (CIL) from developments.
- Without a plan: Receives only 15% of CIL and has a perceived reduction in influence on development decisions.
- Planning applications are assessed against the Local Plan when a Neighbourhood Plan is in place.

Climate Change Guidance – Objectives

- Help communities understand the role of planning in mitigating climate change impacts.
- Provide practical ideas for planning policies.

- Explain the role of community actions and answer common questions.

Key Updates

- Solar Farms: The threshold for a project to be considered a Nationally Significant Infrastructure Project (NSIP) has increased from 15 MW to 100 MW.
- Green & Blue Infrastructure:
 - Green Infrastructure relates to plants and natural habitats.
 - Blue Infrastructure focuses on water bodies, including ponds and flood mitigation.
- Biodiversity Net Gain (BNG):
 - Developed in collaboration with Suffolk Wildlife Trust.
 - Hadleigh has a 20% BNG target, which can serve as inspiration.
 - Plans could set BNG requirements to ensure quality and impact.

- Joint Consultation: 6-week period from 29th January – 12th March.
- Document Update & Review.
- Final Draft Presentation to LPWG in March.
- Adoption & Publication.
