Statement of the Representations Procedure **Community Infrastructure Levy – Draft Charging Schedule**

Document title

Raising funds for infrastructure delivery: Consultation on Draft Charging Schedule, October 2012

Subject matter and area covered

The Community Infrastructure Levy (CIL) is a new standard charge which local authorities in England and Wales can charge on most types of new development in their area. CIL charges will be based on the size, type and location of the development proposed. The money raised will be used to pay for infrastructure required to support development in the District.

The Draft Charging Schedule sets out the Council's proposed rates of CIL in the area for which it is the Charging Authority. The Council is the Charging Authority for the entire District excluding the area covered by the Broads Authority.

Period within which representations must be made

The Council invites representations prior to submission for independent examination. Representations are to be made over a six-week period commencing 9am Friday 5th October and ending 4pm Friday 16th November 2012.
