Details in relation to Schedule 12 'Noise' and Annex W 'Noise Mitigation Scheme' of the Sizewell C Project Deed of Obligation in respect of Sizewell C Nuclear Power Station Development Consent Order (DCO) 2022

The following documents were submitted to East Suffolk Council by SZC Ltd. in relation to specific requirements within Annex W 'Noise Mitigation Scheme' of the Sizewell C Project Deed of Obligation, on 21 March 2024.

 Deed of Obligation, Schedule 12, Annex W: Refreshed Noise Assessment: Two Village Bypass Construction (Revision 1.0)

The specific sections of the Noise Mitigation Scheme relevant to this submission include paragraph 1.2.3 requiring the submission of a phasing plan for the refreshed noise assessments and paragraph 1.2.5 requiring refreshed noise assessments be submitted to and agreed by East Suffolk Council. This submission includes a proposed phasing plan for the refreshed noise assessments, and the refreshed noise assessments for the Two Village Bypass construction works.

East Suffolk Council's Environmental Protection team reviewed the submitted document and noted the assessment appears to take a conservative approach to the delivery of the Noise Mitigation Scheme and considers the conclusions drawn to be reasonable. On that basis and due to the inherent flexibility, that has been built into the Noise Mitigation Scheme that allows reconsideration of eligibility throughout the life of the project they are content to accept this document as currently adequate to discharge the responsibilities of SZC Ltd. in this regard.

The details given within the Deed of Obligation, Schedule 12, Annex W: Refreshed Noise Assessment: Two Village Bypass Construction (Revision 1.0) and accompanying e-mail containing the phasing plan received 21 March 2024 in respect of paragraphs 1.2.3 and 1.2.5 Annex W Noise

Mitigation Scheme of the Sizewell C Project Deed of Obligation in relation to the Two Village Bypass construction works are acceptable.

Subject to work being carried out in accordance with those details, the aforementioned paragraphs within the Deed will have been complied with to the local planning authority's satisfaction in relation to the Two Village Bypass construction works.

Please note however that this letter only relates to the Two Village Bypass construction works, further approvals under the Noise Mitigation Scheme will be required in relation to works outside those identified.
