WORKFORCE SURVEY UPDATE

- RC presented a summary of the Spring Workforce Survey results.
- SZC along with the AWG is looking at how to increase the accuracy of this data for the next survey.
- There is potential for DoO payments to depend on workforce numbers, highlighting the importance of data reliability.
- AR suggested that clearer communication about the purpose of data collection might improve response rates, emphasising the obligation under the DCO.
- RC confirmed that summary outcomes of survey will be released, and SZC colleagues are willing to explain how the results were derived to the councils.
