

#### **Working Groups and Forums**





#### MAIN DEVELOPMENT SITE FORUM

Through the Main Development Site Forum, representatives from communities located in the immediate vicinity of the Main Development Site of Sizewell C can raise and discuss construction progress and key issues affecting the local community.

#### ANNUAL COMMUNITY FORUM

The Annual Community Forum meeting will be open to the East Suffolk community, to hear updates on the work of the Main Development Site Forum, the Southern Transport Forum, and the Northern Transport Forum. We'll discuss key issues for local communities and ways to minimise impacts and maximise benefits to those living and working nearby.

#### NORTHERN

The Northern Transport Forum is where we'll discuss all things road and rail, with representatives from communities located in the immediate vicinity of the Northern Park and Ride Site, Yoxford roundabout and other highway improvement works sites, and Sizewell Link Road.

#### SOUTHERN TRANSPORT FORUM

In this Forum, we'll focus on road and rail transport issues and opportunities, with representatives from communities located in the immediate vicinity of the Southern Park and Ride Site, Freight Management Facility Site, and the Two Village Bypass Site.



#### **Transport Review Group**

## **HGV Management**




The Construction Traffic Management Plan (CTMP) includes prescribed HGV routes and HGV caps as well as other measures and controls.

Initially the cap is 600 two-way HGVs and buses per day (300 each way).

SZC is not expecting to operate at the HGV daily cap until towards the end of 2024.

The HGV caps and routes will be monitored with the Delivery Management System (DMS), which is in operation.

Monitoring data will be reported to the Transport Review Group and the Transport Monitoring Reports made public.




#### Traffic Management Countywide Highways Signage

#### **Speed Limits and Compliance**



- Lover's Lane DCO powers for temporary 30mph / permanent 40mph.
- SZC Co is liaising with the authorities and Town / Parish Councils to monitor speed compliance on the B1122 and B1125.
- A12 average speed cameras to be operational from Spring 2024 for ~8wks opposite Friday St.

#### Schemes – Phase1 H1 2024

- Aldhurst Farm Access Improvement Circa 1 week, lane closure
- Upper Abbey Farm Drive Access Circa 1-week, Private Road Closure/ Limited Access
- ACA Secondary Access Circa 1 week lane closure
- B1122 Resurfacing Rolling TM through Q1



#### Jan 2024 Update


- Detail design ongoing. working with SCC Highways to develop opportunities
- Archaeology clearance for access to Rail overbridge
- Ecology clearance required for access
- Main construction to start in 2025
- Land will be transferred to SCC as adoptable highway.
- Utility works planned preconstruction

## Sizewell Link Road




#### Site Works in 2024

- Archaeology clearance for access to Rail overbridge
- Circa 10 months' work to set piece excavations
- Ecology clearance required for access
- Overbridge is project critical



## Yoxford Roundabout





#### Yoxford Update

- Yoxford is a key early years' mitigation and safety improvement
- Detail design is complete and now with SCC for comment and approval
- Archaeology clearance for access to build roundabout expected Summer 24
- Minor ecology clearance required for access to fields
- Circa 8 weeks' work to set piece excavations depending on finds
- Utilities diversions required to Openreach and Essex & Suffolk water apparatus prior to main works. Dates to be agreed.
- Land will be transferred to SCC as adoptable highway.
- Main construction to follow on in late 2024 early 2025.
- Construction period expected to be nine months. To be agreed with contractor once appointed.
- Tie in to A12 to be managed avoiding the need for long duration disruption to the network.

## Northern Park and Ride





#### Key activities and timescales

- Detailed design underway and to be completed by Q3-24.
- Ongoing engagement with SCC-Highways for public road designs
- Limited-extend on-site surveys planned for Q1/Q2-24
- Construction of temporary site access and temp. site establishment works (in support of Archaeology and Vegetation Clearance works), planned for Q2-24
- On site early works (archaeology, ecology) will last 5-7 months; to be completed by end of 24.
- Utility Diversions (Telecom, Power, Water) planned for Q3/4-24. Detailed schedules and plans are being developed in collaboration with statutory undertakers.
- Main construction works to commence in Q1-25.
- Construction period expected 12-15 months.
- North Park & Ride to be operational early-2026. (Opportunity for earlier partial operation is examined, if necessary)
- Working closely with the Rail-projects and Network Rail with regards to the Darshan Level Crossing upgrade.

## Noise Mitigation Scheme



- Noise Mitigation Scheme is secured in the Deed of Obligation (DoO) Schedule 12, Annex W.
- Mirrors the government Noise Insulation Regulations (1975 (as amended 1988):
  - Secondary glazing and mechanical ventilation
- More precautionary in that:
- Regs only apply to new or amended roads (kerb line)
- NMS includes existing roads to be equitable
- Regs do not have a separate night-time threshold, NMS does





## Eligibility for NMS

-The B1122 Properties as listed in the DoO Schedule, Annex G

- Others refreshed noise assessments agreed with ESC / SCC (road traffic only)

- Look at absolute levels and change in levels using agreed traffic data from the ES / forecast construction noise

#### NB:

Not time limited – properties remain eligible while source of noise which gives rise to eligibility remains (assuming time remains for insulation)
Welcome feedback from Parish Councils – any residents that may need extra support / any issues arising in the Community

#### B1122 Vibration Scheme



- In response to consultation and the link road being built in the early years (rather than precommencement)

- Applies to the list of The B1122 Properties listed in Annex G of the DoO only (residential scheme only)

- Secured in second deed of variation to the DoO
- Invitation letters sent December 2024, reminder sent January 2024
- Time limited response by 31 January 2024
- Surveys by May 24 to be repeated following opening of Sizewell link road
