














## Item 6: Green Rail Line Update

#### **Rail Overview**

#### **DCO** Requirements:

- Rail infrastructure works to enable delivery of materials to SZC site by rail, thus reducing number of HGVs and impact on local community
- Journeys from Ipswich to site and back only
- Overnight trains to avoid disruption to other rail services
- Rail noise mitigation plan acceptance by local authority


#### **Noise & Vibration Impact Mitigation:**

- Design to avoid trains stopping / starting en-route
- Replace jointed track with continuous welded rail
- 10 mph running in urban areas & branchline
- Trains not permitted through Leiston at night (11pm to 7am)

Description	Start Date
2 trains / day to ACA railhead *	Jan 2026
4 trains / day to TCA (via GRR) *	Apr 2026
ACA & GRR removed	2037 (approx.)

<sup>\*</sup> Each train removes 46 HGVs from local roads




## **Footpaths & PRoW Overview**

- DCO/DoO provide framework for consented changes in PRoWs/permissive network
- "Rights of Way Access Strategy" is the key document setting out the details
- Temporary PRoW diversions require approval of SCC under Requirement 10, upon submission of "Implementation Plans"
- Strategy also obliges SZC to enhance the permissive network/access to green space
- DoO establishes "Rights of Way Working Group" and £2.5m PRoW Fund to further enhance the PRoW network in East Suffolk





What enforcement measures, in detail, are currently being undertaken to enforce the 30 mph speed limit on the B1122, and with what results?

2)

How can the promised average speed camera system for the B1122 be accelerated so that it is in force significantly earlier than a full year after the start of the 'Early Years' phase?





#### Submitted by Pat Hogan, Sizewell Residents (preamble)

Residents, visitors, and fishermen (both commercial and hobby boats) are very concerned regarding the extent encompassed by the southern boundary of the Harbour Area, that is, the whole village beach and inshore marine area right up to Beach View Caravan Site when this seems totally unnecessary, and an excessive intrusion, especially as all the work for the project is to take place north and east of the A station.

Would you please do all you can to reduce the extent of the Harbour Area Southern boundary?

When I asked the reasons for the extent of the Harbour Area to the south, I was told the decision was based on Hinkley experiences and that here at Sizewell there are no visual markers for ships to know whether they are in the Harbour Area or not.....

The coastline at Sizewell is very different from Hinkley as regards local usage as an important amenity, i.e. the extent of the area mattered less at Hinkley. In addition here at Sizewell all shipping /traffic from the south has to stay 3 miles out in any event due to the sandbanks etc, and then approach in a westerly direction, and therefore no extended Harbour Area is required for that.

As regards there being 'no visual markers' we do have a massive A station and B station, as well as there being the A station rigs, both of which are also clearly marked by Trinity House approved lit buoys. All shipping presumably will also have the use of GPS.

It is also bewildering that no specific consultation regarding the extent of the Harbour Area or appointment of a Harbour Master seems to have taken place, nor any specific information given out locally. We of course realise that a certain safety zone has to be in place and respect that, but we understood this area to be the Main Development Site Boundary marked by a heavy red line on all the information we had, with possibly an extended area to the north and east, but certainly had no inkling that this would extend south of the A station, right across the main amenity of beach, all the leisure boats, and inshore area, as far south as Beach View Caravan Site – this was presented as a fait accompli, and is causing great upset.

#### **Question:**

Can you please look again at the exact situation here at Sizewell and do all you can to reduce the extent of the boundary to the south - making the Harbour Area southern boundary to be the A station southern rig and buoy, and leave the village beach and inshore frontage without the unnecessary intrusion and excessive jurisdiction (and accompanying loss of freedom of movement, particularly for the small inshore boats at Sizewell) that comes with the nomination 'Harbour Area' with a 'Harbour Master'? It would help us enormously.

Can something be done to slow down the Traffic on the road into Sizewell as the turning to the Caravan Site/Sizewell Hall Road/Ness House etc., is becoming very dangerous when you turn into this and the situation has worsened in the last few months.







#### **Submitted by Aldeburgh Town Council (1)**

Aldeburgh is a town with an economy firmly rooted in Tourism. It is imperative that towns such as Aldeburgh continue to thrive. Not only for the benefit of the various businesses and their employees but for all the residents, the holidaymakers, the day visitors, the second homeowners and of course all the employees of and visitors to Sizewell C and the surrounding area including Snape Maltings, Minsmere RSPB and many other places of interest

This vital economy is likely to be negatively affected because of the exaggerated pay rates for on-site staff and the inflated long-term and short-term rental offers being made to homeowners, which is amounting to unfair competition.

Local businesses can only survive if they are able to recruit and retain the staff they need, and if rental accommodation (for workers and customers) is available. They also have to remain competitive in an increasingly difficult trading situation, and in an area of relatively low unemployment. Businesses simply cannot match the offers being made by SZC and have already lost staff to higher paid opportunities – this was also experienced during the construction of Sizewell B

It is vital that a balance is found between the needs of Sizewell C and the needs of the surrounding communities and businesses for the future prosperity of all.

Aldeburgh Town Council understands the criteria and objectives of the Tourism and Accommodation fund, however would you please advise what steps you will be specifically putting in place to ensure that the surrounding communities and businesses are not negatively impacted as a result of these exaggerated pay rates and rental offers?

#### **Submitted by Aldeburgh Town Council (2)**

Impact of construction on the beach (widely enjoyed by local residents for their health and well-being, and our many visitors as part of the tourism offer) and impact on coastal processes as an example of communication and involvement of Town and Parish Councils.

From the Agenda it is not possible to understand if our request to discuss beach closures and diversions as a standing item (previous minutes 9.01 & 9.02) has been included.

Aldeburgh Town Council would also request more communication regarding matters considered by the various working groups. There have been examples since the last meeting whereby websites have not been kept updated promptly with minutes or notes, such as of the Transport Working Group and PRoW working group which considered the beach path diversion.

Would it be possible to have a focus group to discuss communication and governance regarding how local authorities (town and parish councils, local ward members and other Clirs of East Suffolk Council and Suffolk Council) can be effectively involved and kept updated?

ATC would also formally request to become members of either the Northern and Southern Transport Forum (as residents and visitors use both the Yoxford and Friday Street junction to access North and South, along with adjacent roads).

If the update on beach closure and footpath diversion is included in the agenda we would still request to ask about communication & governance.





#### **Submitted by Aldeburgh Town Council (2)**

Would it be possible to have a focus group to discuss communication and governance regarding how local authorities (town and parish councils, local ward members and other Cllrs of East Suffolk Council and Suffolk County Council) can be effectively involved and kept updated?

Submitted by Cllr Sarah Whitelock, East Suffolk Council on behalf of resident, Mike Taylor, who asked:

Please can you give an update on the cut off wall to be constructed near the perimeter of the nuclear licenced site boundary I understand this is a 2 km long wall to a depth of 50 metres and around 1.5 metres wide to create a watertight box around the main construction site.

Is it possible to see precise drawings and timescale for this work?

When will construction of the roundabout at the top of Eastbridge road on the B1122 start, and during construction of the roundabout will you ensure that the road to Eastbridge will always be open so that local businesses will always be able to receive deliveries and go about their daily business?





#### Submitted by Leiston-cum-Sizewell Town Council (1)

HGVs delivering to site are still regularly parking in lay-bys on the B1122 and are being reported by residents. This will deter tourists during the summer months. When will there be facilities on site to cater for the needs of lorry drivers (both men and women) who need to stop for a comfort break and refreshments and equally importantly, are legally restricted to the number of miles they can drive before taking a break? Parking in lay-bys will no doubt result in anti-social behaviour and we are disappointed that facilities like portaloos and parking bays for short stops were not placed on site in time for the early years.
