		The Chair reminded attendees of the purpose of the meeting. In essence, this is a forum for sharing information with the ability to escalate matters up if necessary. This group was established as part of the Deed of Obligation when it became clear there was no conduit in place for joining up the various organisations involved in the SZC project.	
		These meetings are conducted under the 'Chatham House Rule' to facilitate the open sharing of information.

3.	Feedback and lessons learned form the first round of the	Sarah Mortimer presented on progress of the SZC Community Fund.  Brief overview of the Fund given:	
	SZC Community Fund	<ul> <li>Will distribute £23m over the next 10 years to East Suffolk's communities – approximately £2m per year.</li> <li>For communities significantly affected by the impacts of SZC.</li> <li>Projects must benefit communities closest to the development/activity sites including Leiston, Yoxford, Saxmundham, Aldeburgh, Snape and Wickham Market. Woodbridge and Lowestoft are not currently deemed as sufficiently close.</li> <li>Projects must help reduce the longer-term effects of SZC construction activity and provide a positive and sustainable legacy.</li> <li>SCF has a team of three working on the Fund supporting organisations with their projects and to apply for funds.</li> </ul>	
		Fund priorities:	
		<ul> <li>Projects should be supported by those living in the wider community.</li> <li>Projects must address the impacts of SZC (or making the most of the opportunities it creates). Many bids do not sufficiently demonstrate impact.</li> <li>Working closely with other organisations to make sure</li> </ul>	
		<ul><li>everyone can benefit.</li><li>Demonstrating value for money.</li></ul>

		Sustainability beyond the funding duration.	
		Awards Panel:	
		<ul> <li>4 x Panel meetings per year. The Panel has chosen to consider all applications received and has not yet taken the option to establish sub-committees.</li> <li>Terms of Reference in place.</li> <li>12 members (4 x independent members, 2 x local residents, 2 x organisations (Community Action Suffolk + University of Suffolk), 2 x ESC, 2 x SCC, 3 x SZC and 1 x Foundation Trustee. The Chair will always be a trustee of the Foundation.</li> </ul>	
		Grant programmes:	
		<ul> <li>Small Grants = up to £10k per year (£30k max).</li> <li>Large Grants = over £10k per year (no maximum).</li> <li>Multi-year projects = maximum 3 years.</li> <li>Applications accepted from Not for Profit groups and town/parish councils.</li> <li>Can apply for more than one grant but can only hold one grant at any one time.</li> <li>Can apply for Small Grants via the website but not Large Grants – prior discussion with SCF required before applying.</li> <li>The Panel see the applications which have been turned down.</li> <li>4 x funding rounds per year.</li> <li>Due diligence checks are carried out on organisations.</li> <li>90% of organisations require a degree of governance support.</li> <li>Scoring matrix used with applications scored and assessed prior to Panel meetings.</li> <li>Applicants are informed of the outcome within 10 weeks of the closing date.</li> </ul>	
		Year 1 successes:	
		<ul> <li>Year 1 successes:</li> <li>The Fund opened in July 2024 and two funding rounds were held in 2024 with the remainder of the funding transferred to 2025/26.</li> <li>21 awards made totalling £1.5m.</li> <li>Set up and mobilisation – Panel is taking its time to build confidence and good foundations.</li> <li>Pre application conversations actively encouraged.</li> <li>Engagement and outreach including drop-in sessions, online bookable slots, targeted work in Leiston, 2 x large scale Meet the Funder events, online meetings etc.</li> <li>Examples of the types of awards made given ranging from £6k up to £201k.</li> <li>All projects have measurable outcomes.</li> <li>Learning and focus for Year 2:</li> </ul>

		<ul> <li>Ensuring balance between quality applications that provide sufficient information for the Panel to make decisions on and accessibility for smaller organisations.</li> <li>The application needs to be robust given the amount of funding involved – can be challenged on some of the awards made.</li> <li>SCF has become more confident in giving advice - want people to speak to them before making a submission.</li> <li>18 applications rejected in the first round and 23 in the second. Main reasons for rejection include applications from outside of the priority areas (mainly Lowestoft), tourism related applications and applications which look too far ahead (beyond 12 months). SCF support those who are not successful with a view to them reapplying in the future where possible.</li> <li>Discussion around those who do not apply because they are ethically opposed to SZC. SCF encourage them to take a step back and consider who is missing out/being affected by their decision not to apply. Although there is an expectation that the Fund will be publicised by successful recipients, it is possible to negotiate to what extent. There are also other funds available and SCF signpost to these.</li> <li>Staying on top of an ever-evolving construction project and the local funding environment to ensure the Panel has accurate and up to date information. This is a challenge given the activities that go beyond the scope of the Fund. SCF make a point of understanding what else is being funded by linking in with other funders to avoid duplication.</li> <li>There is significant data available in terms of demographics, housing, living standards, education, earnings, skills etc to help target the Fund.</li> <li>Now starting to follow up the first awards made.</li> <li>The impact of Local Government Reorganisation will need to be taken into consideration in terms of the Ded of Obligation. Currently the Fund only relates to East Suffolk but it may have to be widened to, say, Ipswich who are already starting to see the impact of the projec</li></ul>	Future agenda item

Once permits have been issued, the EA will regulate site activities for compliance with the emission limits specified by the permits.  • Social — ESC has funding for Community Safety Officers who are working on the ground. There has been a small increase in anti-social behaviour/low level crime but the Police have not seen an escalation in demand for their services. They have a good structure in place in terms of staffing and potential issues are being actively monitored. There are some 'bubbling' issues at Pontins which the Police are monitoring. SZC are managing and tracking worker vehicles better than at Hinkley.  • Staffing — although some staff have moved over to work for SZC, this was not reported by any attendee as a significant issue for them at the current time.
