Meeting Notes:

1 WELCOME & INTRODUCTIONS

SA opened the panel and outlined the meeting agenda.

This was followed by an introduction by all those present.

2 MINUTES OF PREVIOUS MEETING

NSt talked through previous action, noting that they were largely to be covered in the meeting but further action clarity was still required on the interface between the panel members and NSi as the Natural Environment Improvement Project Officer.

3 UPDATE ON TERMS OF REFERENCE

SA and NSt noted that these had now been approved by the Environment Review Group.

4 UPDATE ON SZC PROJECT

SM talked through the presentation and flythrough presented by NSt

SA queried interfaces with bridleway 19 and SMan explained the existing management procedure in place onsite.

NSi presented an updated timeline. It was agreed that the fund should be launched in summer 2025 noting the importance of public relations and communications around the fund.

The Panel discussed the 'application window' proposal and it was agreed the fund should always be open for application, however clear deadlines would be provided for review period related to each NEAP meeting.

The Panel also discussed initial applications within the first round. It was discussed that the first application window could be restricted to smaller applications in order to trial the process. No vote was held on this matter.

6 NEIPO RECOMMENDATIONS TO NEAP

NSi presented an overview of the appraisal process, including scoring matrix, that would be followed once and application has been received.

The Panel discussed the application process and whether smaller applications were required to follow the same process.

NSi proposed a guided approach to a minimum and maximum grant awards as fund is targeted towards larger applications to address landscape scale impacts.

SA raised that ESC and National Landscapes have a number of smaller grant pots that would be suitable for smaller projects. It was noted that small applications would increase administrative burden on NEIPO and detract from other larger scale applications that require detailed consideration.

A vote was held and it was unanimously agreed that applications under £10,000 would follow the streamlined process. It was agreed that the smaller applications would all be presented at NEAP meetings within a single agenda item where the NEIPO is minded to recommend all applications in this category for approval for expedience.

The Panel then discussed the assessment criteria in further detail. It was noted that the fund would not be seeking to support project scoring less that satisfactory.

7 NEIF APPLICATION PACK

The Panel discussed the application pack in further detail. This included minimum and maximum project sizes, costs to develop proposals, contingency, eligible funding and match funding.

It was agreed by the Panel that there would be no limit to the number of applications by an individual or organisation, but judgement would be applied by the NEIPO and the Panel.

The Panel notes that legal costs could be included in an application but would be considered as part of the application review process. It was also agreed that second hand equipment was an eligible cost but maintenance would not be eligible.
