#### 2 SZC PROJECT UPDATE

SZC presented the latest drone footage of the Main Development Site (MDS) and Offsite Infrastructure Schemes (OSI). Site clearance and archaeology is ongoing at the Sth P&R, Yoxford, the Sizewell Link Road and Two Village Bypass. Work at the Nth P&R will be starting in the coming weeks. Work is progressing well on the MDS with the main access road within the site now surfaced. The focus of the coming weeks will be

to progress work on the OSI schemes and commence key activities on the MDS such as the initial work on the SSSI crossing.

## **3** DEED OF OBLIGATION GOVERNANCE REPORT

RB referenced the recent governance report that was circulated. First anniversary Deed of Obligation payments will be made on 15<sup>th</sup> January 2025. Governance group meetings have been scheduled for the next 12 months. MM noted that some of the dates/times of the environment groups have yet to be fixed, which needed to be done as soon as possible. RB agreed and that this was being arranged as a priority by the team.

### Action: SZC to confirm that dates for the governance groups have been scheduled for 2025.

MM commented that the governance slides related to the financial position of the Deed of Obligation were very helpful and may be useful to be included in an update at the appropriate Forum.

It was agreed that the DSG would keep under review the latest version of the SZC Emergency Plan and advise whether any updates were necessary, over and above those resulting from the existing review cycle. To be discussed at the next meeting.

### 4 ESCALATED MATTERS FOR RESOLUTION

The Planning Group Meeting on 14/11/24 proposed a recommendation to the DSG with regard to Schedule 15 of the Deed of Obligation. The current wording of clause 3.3 and 3.4 specify that not less than specific the sums paid against each clause can be applied to the uses stated. The DSG are requested to confirm that there is some flexibility to utilise the total fund between the two pots and that the funding provided is not required to be spent to the penny in any given year, with flexibility to carry over unspent sums to the subsequent year.

The DSG unanimously agreed that the intent of Schedule 15 is to provide payments to the Tourism Fund which should be applied to all of the uses specified in clause 3.3 and 3.4. Provided that the overall individual sums were broadly in line with the agreement, there should be some flexibility in the total spend against clause 3.3 and 3.4. Additionally, it would be acceptable for any unspent sums to be carried forward to the following year if there is an appropriate use in line with guidance from the Tourism Working Group.

## 5 KEY RISKS ISSUES AND OPPORTUNITIES

MM raised the importance of clear communication regarding the implementation of the Friday Street roundabout and how the requirements for Scottish Power Renewables (SPR) traffic are fully considered in the planned construction methodology. DP agreed and confirmed that there was ongoing coordination being held with SPR on this and other road schemes to be delivered in order to align the approach. MM stated that SPR should be encouraged to attend the next local SZC Forums to help present that aligned approach publicly.

Action - SZC to confirm agreement with SPR on the delivery of the Friday Street Roundabout and encourage attendance at SZC Forums.
