Sizewell C

Minimize disruption to local communities during the construction of Sizewell C.	Transport the majority of construction materials by rail and sea, significantly reducing the number of Sizewell C HGVs on local roads.	Provide a comprehensive 24/7 onsite occupational health service for workers, a healthcare contribution and a Public Services Contingency Fund.
Invest in local employment, education and skills. This includes an aim to enable 1,500 apprenticeships.	Respect the Suffolk Heritage Coast and minimise impact on RSPB Minsmere, National Trust Dunwich Heath and Leiston Abbey.	Require all workers to sign a Worker Code of Conduct and enforce it – as we have done successfully at Hinkley Point C.
Support the growth of the local economy. This includes measures to support local firms in gaining work on the project.	Return the temporary construction area to a standard befitting the Area of Outstanding Natural Beauty (AONB) following construction.	Enhance the economic, social and environmental wellbeing of local communities through the provision of a Community Fund.
Remove the accommodation campus and caravan site, the park and ride sites, the rail extension of the Saxmundham to Leiston branch line and freight management facility following construction and restore the land.	Support the Suffolk coast tourism sector to offset impacts from construction through the provision of a Tourism Fund.	The Sizewell C Project will not impact on the supply of water to local residents by a single drop. We have a sustainable strategy to provide potable water throughout construction and the operation of the new power station.





DCO Progress to Date




Multiple milestones have been achieved in the last year, including the convening of many governance groups and forums








Project Milestones

- Our first key milestone to be achieved is the completion of the fencing around the perimeter of the site which is an essential requirement in securing our Nuclear Site Licence.
- Our second milestone is the completion of our access to the Ancillary Construction Area (ACA) from King George's Avenue, which means we are ready to start the fit-out of the new Welfare Hub.
- Finally, the third milestone now complete is the resurfacing on the B1122 which is currently the main access road to site. Works were carried out overnight to minimise disruption to local residents and form part of our commitment under the Sizewell C Deed of Obligation. The resurfacing has improved the condition of the B1122 which will reduce noise and vibrations generated from traffic. The B1122 route is significant as it is the main road through Leiston to site and will be used by all construction traffic until the Sizewell Link Road has been constructed.







Suffolk Community Foundation and the Sizewell C Community Fund



About Suffolk Community Foundation

• We

- are a small but passionate team of 15 staff based in Wherstead
- are a registered charity which was set up in 2005 and is one of 47 community foundations in the UK
- give grants to charities and community organisations so that they can support disadvantaged local people to improve their lives
- help individuals, businesses, professional advisors and charitable trusts to fund projects which tackle the issues they care about the most
- have given 9,500 grants totalling £40 million to over 3,000 local charities and 12,000 community groups to date





About Suffolk Community Foundation

• We

- work across the whole of Suffolk
- award around £5 million in funding each year, which range from grants of £500 to £40,000 over several years. The average amount awarded is £3,500
- support both large and small organisations by helping them apply for grants
- have extensive knowledge of the communities we work with and their specific needs
- have been asked to manage the new Sizewell C Community Fund as a result of our track record and experience





The Sizewell C Community Fund

- A pot of up to £23 million in funding which will be directed into the East Suffolk Council area over the next decade
- Around £2m will be available each year
- Grants will be awarded to schemes which will:
 - minimise the impact of construction work
 - improve environmental, social and economic wellbeing
 - generate new education and employment opportunities
- Two staff have been appointed to manage the fund



The awards panel

- The panel will meet four times a year to decide on applications
- It will be made up of:
 - a Suffolk Community Foundation trustee, who will chair the panel
 - two representatives from Suffolk County Council
 - two from East Suffolk Council
 - three from Sizewell C
 - four independent members including two with a strong connection with the area; a researcher from the University of Suffolk and the CEO of Community Action Suffolk
 - Helen Taylor will chair the panel. She is an SCF trustee with extensive experience in community development as well as the charity, governance and health sectors









The awards criteria

- The panel will meet for the first time later this month to discuss the awards criteria
- There will be no upper limit on funding and awards can be made across multiple years
- The full criteria will be published on our website once it has been agreed by the panel
- We will then start inviting bids and hope to award the first grants in the summer



Next steps

- Finalise membership of the awards panel and the awards criteria
- Open the fund for applications. This will be advertised on our website – <u>www.suffolkcf.org.uk</u> – and our social media channels
- Keep stakeholders, our donors, charities and community groups informed of progress and listen to their feedback
- Update our website and the local media when awards are made to show the impact the funding is having

Will all workers at Sizewell C be required to live in the EDF provided accommodation, and if not, how can local people be reassured that the rental market will not be dominated by workers from Sizewell?

(Specifically ATC is not represented at either the North or South Transport forums and other peer Councils are also not represented on the Main Development Site forum). And could this Community Forum meet more frequently than annually please?
- Working Groups: How will the Economic, Social and Environmental working groups function in relations to the Forums, and how can Town/Parish Councils in general and ATC specifically engage, inform and support these to deliver the pledges in the Deed of Obligation including benefits (such as employment and training) and mitigations (such as impact on Tourism).

- We are yet to see an updated timetable for the project. We do understand that dates are fluid but we would like to see a flow chart which indicates the timeline for: For example: Park and Ride completion; Campus completion; Link road completion; Leiston Town Centre Traffic and Transport Plan completion; Contractor numbers; Park and Ride (North and South) completion; 2 village bypass completion; Yoxford roundabout completion; Green rail route completion. And likewise, when temporary associated development might start to be dismantled. This might seem a hard call for SZC but gives the community the opportunity to adjust to the project and understand the challenges ahead. If this document is already available, please send links to the towns and parishes.
- We note you have held Community Days in Ipswich. These are for people to find out about the opportunities that Sizewell C will bring. It therefore seems a strange decision to not hold the first of these close to the site itself. When will you be holding a Community Day in, or close to, Leiston?
