



Teresa Howarth– East Suffolk Council Housing Fund



Increase supply of bedspaces in private housing

Applications are now open for two new grants to help East Suffolk homeowners get ready to rent out high quality accommodation to Sizewell C workers.

MINOR WORKS GRANTS

 Up to £3,000 per bedroom is available to turn an unused bedroom into accommodation for a Sizewell C worker. This can cover things like repainting, new flooring, electrical upgrades, extra heating, new windows, or adding a washbasin.

RENOVATION GRANTS

 Up to £7,000 per bedroom is available for larger projects, including converting buildings to homes, structural work, electrical rewiring, heating installation, new windows and doors, plumbing, and adding kitchen or bathroom facilities. This grant can also be used to create shared accommodation - Houses in Multiple Occupation (HMO)-

* Extra funding on top of these amounts is available for work needed to improve the property's Energy Performance Certificate (EPC) rating to C *

- Increase the housing supply of accommodation through funded incentives.



















- Working groups on logistics and communications up and running









Transport Monitoring Reporting Q3 2024




Average (Mean) and Maximum Daily HGV Movements



SIZEWELL C WORKER CODE OF CONDUCT

The Sizewell C Project operates a Worker Code of Conduct designed to set clear expectations for the behaviour of all workers, whether on site or in the local community. The SZC Worker Code of Conduct, (the "Code"), will help to achieve the following:

Explain the behaviour expected of workers and outline the means by which the Code will be communicated. This expectation will also inform the local community of the standard of behaviour they should expect from the workers and their employers.

Inform workers about the possible consequences if the code is not upheld.

Recommend actions for workers when behaviours contrary to this Code have been observed.





Suffolk Constabulary Statement

Suffolk Constabulary is continuing to work closely with stakeholders and local communities to ensure it provides the appropriate policing support as the construction of Sizewell C commences.

We have also engaged with and visited our Avon and Somerset police colleagues at Hinkley Point C to learn from the approaches they took with a very similar construction in their policing area.

From the outset we have considered the impact on the local road network, and this was a matter that was subject to much discussion in the planning hearings. We have enhanced our road policing provision in and around the Sizewell area to ensure the safe movement of large loads travelling to and from the site, to focus on road safety and, where appropriate, on traffic offence enforcement.

If you witness a traffic incident, that does not require an immediate response from the emergency services or have concerns or information for the police about traffic matters in general, please ensure that you follow the same procedures that are already used across Suffolk and report online.

Please tell us what is happening in your community so we can provide an appropriate and proportionate response.

Remember call 999 if an incident requires an immediate response from the emergency services







- 1) CA PC is pleased that the traffic monitoring has now happened, even if this is a year late and therefore not truly establishing a baseline. As this is part of the Deeds of Obligation, how comes this was not done immediately - as per DoO?
- 2) Should PC's be concerned this being a sign of things to come?
- OA is concerned that key secondary roads are currently not captured via the permanent monitoring and hence impacts will get picked up too late for the Transport Group to enact remedies. Could we please have a list of the permanent traffic monitoring places currently in use and could PC's have a stake in choosing additional locations deemed necessary?



Question:

Coordination at the Friday Street junction - The solution proposed at the Friday Street junction for the Scottish Power projects was the installation of traffic lights on the southbound carriageway to allow northbound traffic to turn right more easily down the A1094, the main construction route for the Scottish Power projects. It is understood that this solution is being abandoned given the construction of a new roundabout for SZC. Given that construction on the Scottish Power projects is expected to start next year, how will the construction of the Friday Street roundabout and the Scottish Power projects be coordinated to avoid traffic congestion and improve road safety on the A12 and the A1094, recognising also that such congestion will spill over into the rural road network?

2) Can there be a standing agenda item in future agendas relating to the coordination of Sizewell C with the Scottish Power and National Grid projects?
