Regulations 2012 and Localism Act 2011.

RENDLESHAM NEIGHBOURHOOD PLAN.

The plan has been prepared by Rendlesham Parish Council following extensive consultation with the local community.

Regulatory Requirements

In accordance with Regulation 15 of the above Regulations, Rendlesham Parish Council as a qualifying body has submitted to Suffolk Coastal District Council:

- A copy of the plan proposal (including a map of the area to which the plan relates);
- A consultation statement; and
- A basic conditions statement.

Suffolk Coastal is now required (Regulation 16) to publicise details of the plan proposal and invite comment ahead of the submission of the plan to independent examination.

When must I submit my comment by?

Comments are invited over the six week period

1 September 2014 to 13 October 2014.

Any comments should be received by the Council by 5.00pm on Monday 13 October 2014.

All submitted comments will be collated and will be made publically available as soon as possible after 13 October 2014.

How should I submit my comments?

Comments on the plan proposal (including supporting documents) are invited via letter or email. Letters should be addressed to Planning Policy and Delivery Team (Neighbourhood Plans) address as above.

All representations should be headed Rendlesham Neighbourhood Plan as the subject matter. Where comments relate to a particular paragraph of policy please ensure that this is also clearly stated.
