1. INTRODUCTION

1.1 This Basic Conditions Statement has been produced to explain how the proposed Neighbourhood Plan for Shadingfield, Sotterley, Willingham and Ellough (SSWE) has been prepared in accordance with the requirements of Regulation 15 of the Neighbourhood Planning (General) Regulations 2012¹ and how the basic conditions of Neighbourhood Planning and other considerations as prescribed by the Town and Country Planning Act 1990 are considered to have been met.

1.2 The Statement addresses the four 'basic conditions' required of the Regulations and explains how the submitted SSWE Neighbourhood Plan meets the requirements of paragraph 8(2) of Schedule 4B to the 1990 Town & Country Planning Act. The Regulations state that a Neighbourhood Plan will be considered to have met the basic conditions if:

- having regard to national policies and advice contained in guidance issued by the Secretary of State, it is appropriate to make the Neighbourhood Development Plan;
- the making of the Neighbourhood Development Plan contributes to the achievement of sustainable development;
- the making of the Neighbourhood Development Plan is in general conformity with the strategic policies contained in the Development Plan for the area of the authority (or any part of that area); and
- the making of the Neighbourhood Development Plan does not breach, and is otherwise compatible with, EU obligations.

2. TERMINOLOGY

- 2.1 Throughout this document:
 - the Shadingfield, Sotterley, Willingham and Ellough Neighbourhood Plan will be referred to as the 'SSWE Neighbourhood Plan'; and
 - The East Suffolk Waveney Local Plan (March 2019) will be referred to as the Waveney Local Plan.
- 2.2 The following abbreviations are used where appropriate:
 - SSWE the joint parishes of Shadingfield, Sotterley, Willingham and Ellough;
 - SSWE-NP Shadingfield, Sotterley, Willingham and Ellough Neighbourhood Plan; and
 - NPPF National Planning Policy Framework.

3. SUPPORTING DOCUMENTS AND EVIDENCE


- 3.1 The SSWE Neighbourhood Plan is supported by:
 - Basic Conditions Statement;
 - Consultation Statement; and
 - East Suffolk Council screening assessments on the need for a Strategic Environmental Assessment and a Habitats Regulation Assessment.

4. KEY STATEMENTS

- 4.1 The following key statements relate to the legal requirements under the **Planning and Compulsory Purchase Act 2004** (see section/paragraph references below).
- 4.2 Shadingfield, Sotterley, Willingham and Ellough Joint Parish Council is a qualifying body and entitled to submit a Neighbourhood Plan for the wards within its own parishes. [Section 38A, para 1]
- 4.3 The SSWE Neighbourhood Plan only includes <u>policies</u> that relate to the development and use of land within the Neighbourhood Area. [Section 38A, para 2]
- 4.4 The Neighbourhood Area is the whole of the parishes of Shadingfield, Sotterley, Willingham and Ellough, with the exception of a small area on the western boundary of Shadingfield parish which is within the village of Redisham (see map below). This area was omitted because it should more logically be included within a Neighbourhood Plan for Redisham parish should that be developed.
- 4.5 The SSWE Neighbourhood Plan covers the period from 2022 to 2036. [Section 38B, para 1]
- 4.6 No provision for excluded development such as national infrastructure is contained within the Neighbourhood Plan. [Section 38B, para 1]
- 4.7 The SSWE Neighbourhood Plan does not relate to more than one neighbourhood area. It is solely related to the Neighbourhood Area of Shadingfield, Sotterley, Willingham and Ellough as designated by Waveney District Council on 11th October 2017. [Section 38B, para 1]
- 4.8 There are no other Neighbourhood Plans in place for the SSWE Neighbourhood Area. [Section 38B, para 2]

5. CONFORMITY WITH NATIONAL PLANNING POLICY

- 5.1 The SSWE Neighbourhood Plan is required to have appropriate regard to national planning policy, which is principally provided by the National Planning Policy Framework (NPPF).
- 5.2 The NPPF (para 2) states that the framework must be taken into account when preparing the Development Plan. It also states that Neighbourhood Development Plans must have regard to the policies in the NPPF and to be in 'general conformity' with the strategic policies of the Local Plan. This phrasing is explained more clearly by the Localism Act which refers to the 'adopted Development Plan'.
- 5.3 This section demonstrates that the SSWE Neighbourhood Plan has regard to relevant policies within the NPPF in relation to:
 - Delivering a sufficient supply of homes;
 - Building a strong and competitive economy;
 - Promoting healthy and safe communities;
 - Promoting sustainable transport;
 - Supporting high quality communications;
 - Making effective use of land;
 - Achieving well-designed places;
 - Meeting the challenge of climate change, flooding and coastal change;
 - Conserving and enhancing the natural environment; and
 - Conserving and enhancing the historic environment.
- 5.4 The SSWE Neighbourhood Plan seeks to address eight principal objectives for the future development of the joint parishes. The NPPF goals addressed by these objectives are shown in Table 5.1.
- 5.5 Table 5.2 then provides a summary of how each policy in the SSWE-NP conforms specifically to the NPPF.

6. CONTRIBUTION TOWARDS SUSTAINABLE DEVELOPMENT

6.1 The NPPF (paragraph 11) states that 'plans and decisions should apply a presumption in favour of sustainable development'. As demonstrated in Table 6.1, the strategic objectives of the SSWE Neighbourhood Plan support sustainable development through a balance of social, economic and environmental goals, as defined in the NPPF.

6.2 East Suffolk Council considered that a Strategic Environmental Assessment (SEA) was not required because the SSWE Neighbourhood Plan is not likely to have a significant impact upon the environment.

6.3 East Suffolk Council considered that a Habitats Regulations Assessment (HRA) was not required because the SSWE Neighbourhood Plan is not likely to have a significant impact upon the environment.

7. CONFORMITY WITH THE STRATEGIC POLICIES OF THE DEVELOPMENT PLAN

7.1 The Development Plan currently consists of the following documents relevant to the SSWE parishes:

- Waveney Local Plan March 2019.
- Guidance for Historic Buildings and Conservation Areas Built Heritage and Design Supplementary Planning Document April 2012.
- Open Space Provision & Developer Contributions Open Space Supplementary Planning Document January 2012.
- Renewable Energy and Sustainable Construction Supplementary Planning Document Adopted September 2013.
- Affordable Housing Supplementary Planning Document May 2012.

7.2 Policies of relevance are shown in Table 7.1 below, along with a consideration of whether they represent the strategic policies of the Development Plan. Where they do, consideration is made of whether the SSWE-NP is in general conformity with them.

7.3 Any policy that is not identified in Table 7.1 is not considered to be relevant to the SSWE-NP because the SSWE-NP does not have any policies that directly relate to it.

7.4 There are no policies in either the 2008 Suffolk Minerals Local Plan or the 2011 Suffolk Waste Local Plan that the SSWE-NP policies have any relevance to.

8. COMPATIBITY WITH EU OBLIGATIONS AND HUMAN RIGHTS REQUIREMENTS

8.1 The Neighbourhood Plan has regard to the fundamental rights and freedoms guaranteed under the European Convention on Human Rights and complies with the Human Rights Act.

8.2 The SSWE Project Team submitted a formal screening request regarding the need for a Strategic Environmental Assessment (SEA) and a Habitats Regulation Assessment (HRA) of the draft SSWE Neighbourhood Plan in February 2020. In March 2021, East Suffolk Council advised that neither an SEA nor an HRA was required. The formal opinions in respect of these decisions are provided as separate supporting documents.

9. CONCLUSION

9.1 The Basic Conditions as set out in Schedule 4B to the Town and Country Planning Act 1990 are considered to be met by the SSWE Neighbourhood Plan and the policies therein. It is therefore respectfully suggested to the Examiner that the SSWE Neighbourhood Plan complies with Paragraph 8(1)(a) of Schedule 4B of the Act.
