Custom and Self-build Housing Supplementary Planning Document

Adoption Statement 7 May 2024

The Custom and Self-build Housing Supplementary Planning Document (SPD) was adopted by East Suffolk Council on 7 May 2024.

The SPD provides guidance on the implementation of policies relating to custom and self-build housing in the East Suffolk Council - Suffolk Coastal Local Plan and East Suffolk Council - Waveney Local Plan. The SPD provides guidance on a range of topics including the definition of custom and self-build housing, affordable custom and self-build housing, serviced plots, Community Infrastructure Levy, phasing, design codes, plot passports, marketing strategies, and neighbourhood planning/community led-housing.

A number of modifications were made to the SPD to take account of representations made in relation to the document and any other relevant matters. Modifications arising from the consultations are set out in the Consultation Statement.

Any person with sufficient interest in the decision to adopt the SPD may apply to the High Court for permission to apply for judicial review of that decision. Any such application must be made promptly and, in any event, not later than 3 months after the date on which the SPD was adopted.
