

Houses in Multiple Occupation 'Exceptional Circumstances' Guidance Note

Adoption Statement 3 December 2024

The Houses in Multiple Occupation 'Exceptional Circumstances' Guidance Note (Guidance Note) was adopted by East Suffolk Council on 7 May 2024.

The Guidance Note addresses the implementation of Waveney Local Plan policy <u>WLP8.4</u> (<u>Conversion of Properties to Flats</u>)¹. This policy requires the demonstration of exceptional circumstances in order for buildings to be converted to Houses in Multiple Occupation (HMO). The principal purpose of the Guidance Note is therefore to provide clarity as to the circumstances that could be deemed exceptional. The Guidance Note also sets out relevant information relating to licensing and building regulations.

Modifications were made to the Guidance Note to take account of internal and/or external representations made in relation to the document. The Consultation Statement sets out the Council's response to each consultation response alongside any changes made to the Guidance Note arising from the consultation responses.
