#### Introductions

The Vice-Chairman chaired the meeting in the absence of the Chairman and opened the meeting, introducing Peter Holborn from the County Council who would be providing the group with a Landscape and Ecology update.

### 1. Review of the notes from the last meeting and actions arising

- Letters in connection with the proposed Business Rates Retention for renewable energy to the CLG and DECC have been circulated to members.
- Press Releases to be discussed under agenda item 6.
- Kevin Rodger will be providing the group with supply chain information in the near future.
- NNLAG meeting and Engagement Event to be discussed under agenda items 3 and 5.
- Draft media strategy to be discussed under agenda item 6.

After minor amendments, the notes from the last meeting were agreed as a true record.

### 2. Update on Sizewell C (SZC) Programme

### Four Villages By-pass meeting

Members and senior council officers from Suffolk Coastal District Council have met with the 3 local MPs to discuss proposals to lobby EDFE for funding towards the Four Villages By-pass (4VBP). Their discussion was summarized. The 3 MPs were largely in support of the need for the 4VBP in the light of the extra traffic from the construction of the proposed SZC power station. Therese Coffey said they would be meeting the parishes in late April. (The county council member for Wilford ward has been invited to the meeting with parishes. It was agreed that Therese Coffey's office should be contacted to suggest that a District Councillor is also invited. **ACTION: GH)** 

### **SPLG**

Senior officers and members have met with representatives from the Sizewell Parishes Liaison Group (SPLG) to discuss community benefit and mitigation. The meeting was very productive for both parties and it was agreed to meet regularly when the need arose.

### Other current activity

### Paper 1

- Skills workshop was held by EDFE on 18 April at Copdock. Approx 50 delegates attended. Presentations were given by Angela Piearce (Head of SZC Nuclear New Build), Jenny Chapman (Skills) and Chris Squires (Supply Chain) from EDFE, and Andrew Hunter from QUOD (who are working for EDFE on the Socio-Economic impact studies)
- The SZC Project Team will be visiting EDFE at their headquarters (The Qube, London) for a tri-partite meeting with the Planning Inspectorate (PINs) which has subsumed the Infrastructure Planning Commission
- The next SZC Planning Performance Agreement (PPA) Board Meeting will be held at Suffolk Coastal on 2 May 2012
- SCDC officers will be meeting Suffolk Police to update them on SZC progress, on 25 April
- Community Engagement Event on 28 May 2012

## **Hinkley Point C (HPC)**

A paper was distributed detailing the PINs examination process which indicates a very tight timetable for the next 9 months. The Hinkley experience highlights the need for local government responses to be in-depth and of the highest quality when making representation to PINs and emphasizes that LAs must be prepared in advance. Personal representation at the preliminary meeting is prohibited and submissions cannot be made once the enquiry is underway, which has led to frustration amongst groups in Somerset. It was suggested that a guide in the form of brief bullet-points could be produced to advise the community that representations must be made to the DCO in writing (max 500 words) within the six-week window provided.

### Flamanville, France

The build programme for EDF's new nuclear plant in Flamanville is predicted to be twice as long as anticipated, at twice the cost. It will come on line in 2016 instead of the predicted 2012. Members suggested that EDFE might be challenged for some answers to the delay and the increased cost.

### **New Nuclear Local Authorities Group (NNLAG)**

Officers and members have recently attended the NNLAG meeting in Anglesey. The emphasis for discussion was the HPC submission, the NNLAG Community Benefit paper and Skills and Supply Chain.

### 3. Landscape and Ecology (Peter Holborn)

Following a presentation, members of the group were asked whether they agreed with the priorities stated:

- Maintaining access to public amenity throughout the build and operation of SZC
- Maintaining green space between Leiston and Sizewell
- Compensatory habitat

Members expressed their agreement that the right priorities had been identified and recognize that sterling work is already being done to protect the AONB and SSSI should the new build be approved; they also noted that the first consultation

phase will guide EDF Energy in their landscape and ecology vision before presenting firmer plans at Stage 2 consultation.

EDF Energy will also be key partners in the implementation of the Shoreline Management Plan; and have met on a number of occasions with the Minsmere Levels User Group. EDF Energy would be legally bound to compensate designated habitat loss at a ratio of 2:1.

In conclusion, members of the group added that input from key landowners surrounding the site would be crucial. Officers were able to re-assure members that the RSPB and SC&H are already actively involved with discussions. There was also eagerness from the group to ensure the design of the build would be as sympathetic as possible with its surroundings, given that it was placed within the AONB. It was suggested that SZC could be an exemplar in its field due to its placement within the AONB; this should be the local authorities' aim.

### 4. Engagement Event (Paul Wood)

Key aims and draft agenda were summarized. Draft agenda was approved by members.

Members agreed that mixed workshops discussing the same issues would be the preferred choice; they would also like to see young people represented and asked organizers to ensure this would be the case.

The event will demonstrate a united front from the two authorities and will show a commitment to stay engaged with the local community throughout the process. Feedback from the delegates will inform JLAG as to how often events of this kind should occur.

#### 5. Communications

SCDC Press Officer was unfortunately unable to attend the meeting. Therefore the draft media strategy and press release will be emailed to members at a later date for comment. **ACTION: NC** 

## 6. Mitigation and Community Benefit at Hinkley Point C

A brief presentation to members summarized the monetary value apportioned to mitigation and community benefit at HPC.
