3 Review - Paper 2 Post Stage 1 Work Programme

The Stage 1 consultation flagged up a number of areas where further work is required in conjunction with EDF to understand the full impacts and mitigation required in order to meet JLAG's strategic objectives:

- 1. Environmental Exemplar
- 2. Maximising Local Economic Growth
- 3. Securing Infrastructure Legacy
- 4. Agreeing a long term community benefits package

Key Milestones coming up:

- 1. Decision for Hinckley will be made on 19th March 2013
- 2. End March: EDF to seek agreement from their board to fund Sizewell C Stage 2
- 3. 23rd April Project Board meeting with EDF to agree future work programme and budget
- 4. EDF indicated that providing green light with Hinckley then there will be times where their key staff will have their focus there, all agreed that pressure to be kept on EDF to ensure that the Sizewell C Project continues its forward momentum post key milestone decisions

Specific areas of work have been identified and organised into their respective work packages, although recognised that all work packages have links to each other:

1. Environment

- 2. Transport
- 3. Land & Water (Coastal Processes)
- 4. Socio-Economic
- 5. Associated Development
- 6. Communications

Activity within each work-strand is split into short term (next 3-6 months) and medium-term (6 months+); also includes refreshed programme structure and the Local Authority/EDF governance structure provided for members information

It was agreed that each work package would be sponsored by a relevant JLAG member. They would act in an advisory capacity for the work package lead.

Emergency Preparedness & Response currently within Associated Development Strand. It was noted, that the councils should seek agreement with EDF that this area of activity should have its own work package.
