Possible that the subtext is that the Government is potentially under pressure as EDF Energy is warning that savings will diminish with every year of delay.	15:21

5	<p>AOB</p> <p>Discussed letters sent to land owners by EDF Energy.</p> <p>Discussed alternative reptile translocation land for EDF Energy's project, should SPR gain consent to build on Broom Covert, Sizewell. Any replacement land would have to be agreed with Natural England & Suffolk Wildlife Trust.</p> <p>SPR are looking for alternative land, SCDC/SCC have offered to help, but so far not been directly involved by SPR.</p> <p>The Chairman confirmed that with regards to SPR's 3.5 consultation, it was set for four weeks, he has written asking for an additional two weeks. This has been agreed and the consultation now ends on 12 November.</p> <p>SCC as Highway Authority has still not had the volume data in regards to transport at stage 3.5 so are unable to judge the impact.</p> <p>It is anticipated that Natural England will only comment on the potential development of AONB land as they consider and can see that an alternative exists outside of the AONB.</p> <p>Meeting ended at 16:20hrs Next meeting 16 November 2018 November meeting to focus on Social Economic and Transport areas in relation to Sizewell C December meeting will focus on Associated Development.</p>	15:40
