Summary

Early Opportunities Workstream

- "We will inform relevant project developers if their current/planned project is considered to be in-scope for the Early Opportunities workstream. ...holding the first of a programme of regular webinars for in-scope project developers in the near future"
- "As these projects are at an advanced stage of development where much of the detailed network design and planning consent work has already been completed, opting-in to a coordinated design is currently voluntary"

Pathway to 2030 workstream

• "Projects in-scope for the HND* and Pathway to 2030 workstream are primarily The <u>Crown Estate Leasing</u> <u>Round 4</u> and ScotWind projects. ...and a handful of other offshore projects which are spatially and/or temporally relevant to other in-scope projects for the HND and Pathway to 2030 workstream. We will inform relevant project developers if their current/planned project is considered to be in-scope for the HND* and Pathway to 2030 workstream, with additional connection contract clauses added into relevant contracts."

Offshore Transmission Network Review: proposals for an enduring regime and multipurpose interconnectors

"We are consulting on proposals to develop a new enduring regime that takes a more strategic approach to windfarm development and considers the offshore transmission system holistically with the onshore network to deliver a more coordinated approach and reduce the cumulative impacts of transmission.

The consultation sets out:

- a range of possible approaches for an enduring regime, ranging from incremental change to a completely new regime
- a provisional recommendation that a more strategic approach is required in any future regime to achieve the Review's objectives
- possible models for an enduring regime and their high-level assessment against agreed criteria

We are not seeking to lock in a specific model at the moment, but will use your feedback to inform further detailed assessment of individual options. We will then consult again on the detail later in 2021."
