East Anglia One North and East Anglia Two Offshore Windfarm Update – June 2021

Examinations

The examinations formally commenced on 6 October 2020 and were due to close on the 6 April 2021. However, the Examining Authorities (ExAs) requested an extension to the examinations, and this was granted until the 6 July 2021.

Following the granting of the three-month extension by the Secretary of State the remaining deadlines in the examinations include:

- Deadline 12 28 June 2021
- Deadline 13 5 July 2021

The Examining Authorities have utilised the extension of time to hold the following further Issue Specific Hearings and publish additional written questions to seek to address outstanding matters:

- Issue Specific Hearing 16 The Proposed Substation Site
- Issue Specific Hearing 17 Draft Development Consent Orders

The Examining Authorities confirmed previously that the remainder of the examinations would focus on the outstanding matters rather than re-visiting areas which have been settled or areas which remain the subject of disagreement (and are likely to remain so) but the Examining Authorities have sufficient evidence to make their recommendations. The focus has therefore been on:

- Biodiversity and Habitats Regulations Assessment (HRA);
- Consideration of alternatives and cumulative impact onshore;
- Flood risk and drainage; and
- Issues around the proposed substations site at Friston, including, but not limited to, considerations of landscape, design, historic environment, visual impacts, and proposed mitigations.

The last two bullet points in the list were the subject of discussion at Issue Specific Hearing 16. The first and second bullet points have been subject of written submissions.

The Councils have continued to provide relevant comments and information at the appropriate deadlines. Deadline 11 was on 7 June 2021 and provided the Councils with the opportunity to provide submissions in relation to the following matters:

- Post hearing submissions including written submissions of oral case from Issue Specific Hearings (ISH) 16 (Proposed substations site) and ISH17 draft Development Consent Order (dDCO)
- Comments on ExA's commentary on and/or schedule of changes to the dDCO (if required)
- Responses to ExAs Further Written Questions (ExQ3)
- Comments on any additional information/submissions received at D10
- Responses to any further information requested by the ExAs for this deadline

Site/Ground Investigations and Archaeological Works

The Applicants commenced site investigation works in relation to the EA1N and EA2 projects in April 2021. The works have been carried out along the onshore Order Limits and have been and are continuing to be undertaken to inform the design of the projects and provide further information in relation to matters such as infiltration testing associated with surface water drainage and archaeological investigations.

Both Councils have received e-mails from local residents expressing concerns in relation to the works. The Applicants have also reported some alleged incidents against the contractors and equipment/machinery. The Councils are engaging with ScottishPower Renewables to establish an appropriate way to address the concerns raised by both the local community and developer.
