### **Local Concerns**

#### **Transport**

- Front load transport infrastructure 4 villages by pass +
- General concern about increased noise/ congestion
- Specific concerns about congestion in Leiston
- Rail must be part of transport infrastructure improvements
- Scale of removal of material from site how will this be managed?

#### **Environment**

- Visual impact development could dominate AONB
- Long term understanding of coastal processes needed (waste on site for 160 years)
- Impact on coastline north & south of site must be understood
- Flood protection implications need to be understood
- Impact on Alde /Ore estuary
- Emphasis should be on mitigation
- Effluent discharge resulting from 3000 extra people





## **Local Concerns**

#### Economy & skills

- Skills mis-match?
- Impact on existing business wage inflation/ loss of labour
- Will local business be 'fit for nuclear'?
- Will EdF guarantee opportunities for local people?
- How much of construction/ operational spend will be local?
- Link between schools and business needs is poor implications for local employment opportunities
- Boom and bust scenario
- Impact on tourism economy

#### Social/ Community

- Will Leiston get its fair share of community fund?
- Pressure on public services health, policing, libraries
- Anti-social behaviour associated with influx of people into local area
- Cost and disruption associated with anti-nuclear demonstrations
- Impact on quality of life during build phase





### **Local Concerns**

#### Safety/ Health

- Safety conerns relating to the build, operation and waste storage
- Impact of radioactive materials on population esp. children
- Terrorist target

#### Other

- Lack of capacity in local accommodation market for temporary workers
- Lack of sustainable housing supply
- Cumulative development concerns e.g. wind farms, port etc
- Concern that legacy not being built into associated developments





## **Opportunities**

#### Legacy/ Community

- Community Fund
- Lasting Community benefit from transport schemes
- Improvements to housing, infrastructure, environment
- Exemplar for environmental management
- Improvements to rail network
- Improved flood defences
- Business rates retention
- Resources to protect AONB





## Opportunities

#### **Economy/ Skills**

- Employment opportunities for young people and unemployed
- Opportunity to up skill workforce
- Supply chain opportunities
- High value/ well paid employment
- Regeneration potential
- Opportunities for colleges through joint working/ knowledge transfer

#### **Development/ Housing**

- Opportunity for Leiston to develop and work with ONR to potentially lift some planning restraints
- Joint working between housing associations and EDF
