# 1. Introduction

The purpose of the Equality Impact Assessment screening exercise is to assess the impact of the emerging Local Plan policies upon different sections of the community.

The Equality Act 2010 requires local authorities to ensure that their plans and policies do not adversely impact upon any particular group. Indeed policies should actively encourage greater equality between different groups. The purpose of the Equality Impact Assessment screening exercise is to assess policies in the First Draft Local Plan about whether they negatively impact upon any particular group. Groups assessed include people of different ages, beliefs, socio-economic backgrounds, disability, ethnicity, gender, sexual orientation, pregnancy and marital status. If the screening exercise identifies that any Local Plan policy has a negative impact upon one or more group then it will be subject to a full Equality Impact Assessment to identify how the policy can be amended so as not negatively impact upon the identified group or groups.

## 2. Methodology

The Equality Impact Assessment is a tool for assessing the potential impact of the Local Plan upon different sections of Waveney's population. This screening assessment identifies equality issues that may require a full Equality Impact Assessment or changes to the document. This screening assessment is broken down into five distinct stages:

1. Consideration of the existing context with respect to equality matter
2. Assessment of each policy/proposal in the Local Plan on particular groups
3. Monitoring of effects
4. Languages
5. Conclusions and Modifications.

### Existing Context

Section 3 of this document sets out the existing context and considers the existing baseline for diversity within Waveney utilising data from the Census

### Policy Assessment

The policy assessment examines each Local Plan policy in turn to see if it is relevant to any of the following groups:

- Age
- religious belief
- socio-economic status
- disability
- ethnicity
- gender
- sexual orientation
- any other groups
- pregnancy
- marriage

If the policy is relevant to any of the above groups then it is assessed to ascertain whether it would have a positive or negative impact on that group together with an explanation about why that impact occurs. If there is no impact on a particular group then the policy is recorded as 'non applicable'.

## Monitoring

If a Local Plan policy is found to have an impact (positive or negative) on any of the groups listed in the Policy Assessment Section it then becomes necessary to ascertain how that impact will be monitored. Reference to the monitoring framework (Appendix 2 of the Local Plan) will enable an assessment as to whether the policy is being monitored as to its impact upon the relevant group. The relevant monitoring indicators for the policy will then be listed in this part of the Equality Impact Assessment.

## Languages

The languages assessment considers the Local Plan as a whole and assesses whether the plan needs to be presented in different languages or whether language is a barrier when considering the policies within it.

## Conclusions and Modifications

The conclusion considers whether the Local Plan as a whole impacts upon any social group within Waveney and whether a full Equality Impact Assessment is required as a result. The conclusion also identifies whether the Local Plan will require any changes as a result of the screening exercise.

## 3. The Current Position

The information below provides an overview of social diversity within the District. It identifies the different groups included in the Equality Impact Assessment, including those of different age groups and genders, ethnic and religious backgrounds and those with a long term health problem or disability. Information is taken from the 2011 Census.

### Age

The information in table 1 below shows the number of people in each five year age group, with the youngest being those aged 0-4 years old. This includes the number of people in each age group and the percentage they account for in the overall population. Both the numbers and the percentage of the total population are compared against regional and national figures for each age group. As can be seen below the percentage of people in nearly all of the age groups under 60 is lower in Waveney than for the regional and national averages. However in age groups above sixty years of age the percentages are higher in Waveney than in either the East of England or England. This indicates that the proportion of elderly residents is higher in Waveney than elsewhere, which has implications for health and social care provision. Indeed this finding is reinforced by the fact that the mean and median ages for Waveney (43.9 years and 45 years respectively) are both higher than for the East of England and England.

## Gender

The total population of Waveney is 115254, of which 56021 are male and 59233 are female (see Table 2, below). Overall the number of males and females is similar for each age group although there are slightly more females overall. Tables 3 and 4 at the bottom of this section show that the number of females is greater than the number of males for age groups over 30 and that this difference increases as people live into old age.

## Race

Table 5 below shows that in 2011 there were a considerably higher percentage of Waveney residents who identified themselves as white compared to the East of England and England. In Waveney 95.8% identified themselves as white English/ Welsh/Scottish/Northern Irish/British as opposed to 85.3% in the East of England and 79.8% in England as a whole. However there were people from a wide range of ethnic backgrounds living in Waveney but they tend to live in very small communities. For example there were 180 people who identified themselves as British Indian. They account for 0.2% of the District's population, against 1.5% in the East of England and 2.6% in England.

## Religion

Table 6 below shows that the percentage of people identifying themselves as Christian in Waveney was 60.7%, which was slightly higher than in the East of England or England. The proportion of those who were

members of other religions was lower when compared to the rest of the region and the country. Notably only 0.3% of respondents identified themselves as Muslim, compared to 2.5% in the East of England and 5% in England as a whole. Another significant difference is that a higher percentage of Waveney residents (30.6%) stated that they had no religion. This compared to 27.9% in the East of England and 24.7% in England who identified themselves as having no religion.

## Health and Disability

As can be seen in Table 7 below the proportion of respondents in very good health is lower than in Suffolk, the East of England and England, although a slightly higher percentage than in these other areas described their health as good or fair. However, the proportion who described their health as either bad or very bad was higher than in Suffolk, the East of England and England.

In addition information from the 2011 Census shows that Waveney has a significantly higher proportion of residents (10.55%) who suffer from a severe limiting health condition than any other District in Suffolk. By comparison there are 7.4% in the East of England and 8.3% in England as a whole who have a severe limiting health condition. There is also a higher number with less severe limiting health conditions (11.8%) than any other district. For the East of England and England 9.3% have a less severe limiting health condition.

However, it should be pointed out that overall the proportion of the population providing unpaid care to a partner or relative does not appear to be significantly higher in Waveney than anywhere else in Suffolk. That said the proportions of residents providing 20-49 hours' care and over 50 hours' care are slightly higher than elsewhere in the county.

**Policy WLP2.16 – Land at South Lowestoft Industrial Estate**

This policy does not apply to any group listed within the Equality Impact Assessment and so no monitoring is required.

**Policy WLP2.17 – Land at Mobbs Way, Oulton**

This policy does not apply to any group listed within the Equality Impact Assessment and so no monitoring is required.

**Policy WLP4.4 Land North of Old Station Road, Halesworth**

**Policy WLP4.5 Broadway Farm, Halesworth**

**Policy WLP7.13 – Land South of Hogg Lane, Ilketshall St. Lawrence**

**Policy WLP8.3 - Self Build and Custom Build**

This policy does not apply to any group listed within the Equality Impact Assessment and so no monitoring is required.

**Policy WLP8.4 – Conversion of Properties to Flats**

This policy does not apply to any group listed within the Equality Impact Assessment and so no monitoring is required.

**Policy WLP8.5 – Gypsy and Traveller Sites**

This policy will be monitored against the number of gypsy and traveller sites permitted, which is identified as an indicator in Appendix 2 of the First Draft Local Plan.

**Policy WLP8.8 – Rural Workers Dwellings in the Countryside**

This policy will be monitored against the number of rural workers dwellings in the countryside completed, which is identified as an indicator in Appendix 2 of the First Draft Local Plan.

**Policy WLP8.9 – Replacement Dwellings and Extensions in the Countryside**

There are no indicators against which this policy can be monitored.

**Policy WLP8.10 – Residential Annexes in the Countryside**

**Policy WLP8.11 – Conversion of Rural Buildings to Residential Use**

This policy does not apply to any group listed within the Equality Impact Assessment and so no monitoring is required.

**Policy WLP8.31 – Residential Gardens and Urban Infilling**
