The Waveney District Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 32, 35 and 101 of the Road Traffic Regulation Act 1984 (as amended) (hereinafter referred to as "the Act of 1984") Schedule 9 to the Act of 1984 and all other enabling powers and with the consent of Suffolk County Council in accordance with Section 39(3) of the Act of 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order.

PART 1: PRELIMINARY

1. <u>Title</u>

This Order may be cited as the Waveney District Council (Off-Street Parking Places) (Variation) Order 2018.

2. <u>Commencement and Effect</u>

This Order shall come into operation on the 1st April 2018.
