**EAST SUFFOLK COUNCIL
(OFF-STREET PARKING PLACES) ORDER 2025**

East Suffolk Council (hereinafter referred to as “the Council”), in exercise of its powers under sections 32 and 35 of the Road Traffic Regulation Act, 1984 (hereinafter referred to as “the 1984 Act”), Part IV of Schedule 9 to the 1984 Act, Part 6 of the Traffic Management Act 2004 (hereinafter referred to as “the 2004 Act”) and of all other enabling powers, with the consent of the Suffolk County Council in accordance with section 39(3) of the 1984 Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the 1984 Act, hereby make the following Order:-

PART 1 – GENERAL

1 Commencement, Citation and Revocations

This Order shall come into operation on the day of 1 June 2025 and may be cited as the East Suffolk Council (Off-Street Parking Places) Order 2025.

The East Suffolk Council (Off-Street Parking Places) Order 2020 and its variation, the East Suffolk Council (Off-Street Parking Places) (Amendment No.1) Order 2021, are superseded by the provisions of this Order.

The East Suffolk Council (Off-Street Parking Places) Order 2020 and its variation are hereby revoked in their entireties from the day of 1 June 2025.

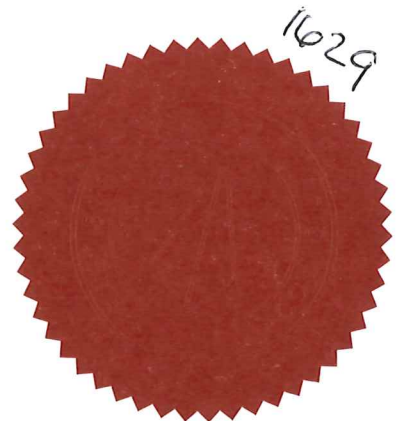

2 Interpretation and Definitions

(1) In this Order, except where the context requires otherwise, the following expressions have the meanings or definitions assigned respectively: -

"the 1984 Act"	Means the Road Traffic Regulation Act 1984.
"the 2004 Act"	Means the Traffic Management Act 2004.
"the Council"	Means East Suffolk Council.
"Season Ticket"	Means a monthly or annual parking session purchased through a payment method permitted by the Council.
"Season Ticket Holder"	Means a person that has purchased a monthly or annual parking session and assigned this session to a valid Vehicle Registration Mark.
"authorised representative"	Includes Civil Enforcement Officers and Parking Attendants, which have the same meanings as in Section 76 of the 2004 Act and Section 63A of the 1984 Act.
"bus" and "coach"	Unless the context requires otherwise, means a motor vehicle constructed or adapted to carry more than eight passengers (exclusive of the driver); or a local bus, and includes vehicles used for leisure and tourism purposes, as well as those used for scheduled services, with Vehicle Certification Agency type approval M2 and M3.
"caravan"	Means any structure designed or adapted for human habitation which is capable of being moved from one place to another, whether by being towed or by being transported on a motor vehicle or trailer.
"cashless parking" and "cashless payment"	Means a method of payment where the required fee or charge for parking, as outlined in Schedule 1 of this Order, is collected by a Council appointed third-party, with payment being made via an electronic system (including the internet, telephone, SMS and mobile app), by credit card, debit card or other means of secure authorised payment.
"charge certificate"	Means a statutory document issued by the Council when no payment, representation or appeal has been made following the issuing of a Penalty Charge Notice, or no payment has been made following the rejection of a representation or appeal against a Penalty Charge Notice.
"charged parking place"	Means a parking place where a fee or charge applies for each period of parking, as outlined in Schedule 1 of this Order.
"chargeable hours"	Means the times during which a fee or charge applies for each period of parking in a chargeable parking place, as outlined in Schedule 1 of this Order.
"Civil Enforcement Area"	Means an area designated for the civil enforcement of highway and parking regulations, as provided for in the 2004

	Act and implemented in Suffolk by The Civil Enforcement of Parking Contraventions Designation Order 2020.
“commercial vehicle”	Means any mechanically propelled vehicle which is constructed or adapted for the carriage of goods, with Vehicle Certification Agency type approval N1, N2 or N3.
“contravention”	Means any breach of the provisions of this Order.
“current”	When referring to a vehicle licence, disabled person’s badge, permit, exemption, parking place suspension, or season ticket; means valid on the relevant date and time.
“disabled person” and “disabled person’s badge”	Have the same meaning as in the Disabled Persons’ (Badges for Motor Vehicles) (England) Regulations 2000.
“disabled person’s vehicle”	Means a vehicle lawfully displaying a current disabled person’s badge, which; immediately before or after any period of waiting allowed by virtue of the exemptions provided through the display of a disabled person’s badge; has been or is to be driven by a disabled person or has been or is to be used for carrying disabled persons as passengers.
“driver”	In the context of a vehicle waiting in a parking place, means the person operating the vehicle immediately before leaving the vehicle in the parking place.
“heavy commercial vehicle”	Means vehicles of Vehicle Certification Agency type approval N2 and N3.
“motor car” and “heavy motor car”	Means vehicles of Vehicle Certification Agency type approval M1, excluding motor caravans.
“minibus”	Means a passenger carrying vehicle of Vehicle Certification Agency type approval M2.
“motor caravan”	Means vehicles of Vehicle Certification Agency type approval M1 constructed to include accommodation space, containing at least: seats and table, sleeping accommodation, cooking facilities, and storage facilities; such equipment to be rigidly fixed to the living compartment of the vehicle.
“motorcycle”	Means vehicles of Vehicle Certification Agency type approval L1, L2 and L3.
“motorcycle bay”	Means a parking bay within an off-street parking place that is reserved for the parking of motorcycles only.
“owner”	When referring to a vehicle, means the person registered as the keeper with the DVLA.
“adjudicator” and “parking adjudicator”	Has the same meaning as in Section 81 of the 2004 Act.
“Civil Enforcement Officer” and “Parking Attendant”	Have the same meanings as in Section 76 of the 2004 Act and Section 63A of the 1984 Act; and by virtue of Section 76 of the 2004 Act a parking attendant appointed under Section 63A of the 1984 Act is a Civil Enforcement Officer in relation to parking contraventions.
“parking bay” and “parking space”	Means any part of a parking place marked out, by use of painted lines or coloured blocks, for the leaving of a vehicle;

	such bays may be designated for the use of specific users or vehicle classes only.
"parking charge"	Means the fee or charge payable for a parking event within a charged parking place during chargeable hours, such charges outlined within Schedule 1 of this Order.
"disabled parking disc" and "disabled parking clock"	Means a device to be used in conjunction with a disabled person's badge which has been issued by a local authority and has not ceased to be valid, and, is capable of showing the quarter hour period during which a period of waiting has begun.
"parking event" and "parking session" and "parking period"	When referring to a vehicle left in a charged parking place, means a period of parking beginning at the time the vehicle is left in a parking place and ending at the time the vehicle is removed from a parking place.
"permit"	Means a physical or virtual permit issued by the Council authorising specified users or vehicles to park within a specified parking place, subject to any additional terms and conditions set by the Council.
"parking place"	Within this Order, means an area not on a highway designated or described as a parking place within Schedule 1 of this Order, the extents of which are indicated via appropriate signing, marking and boundaries.
"Parking Services"	Means the service established by the Council to carry out regulated parking administration and enforcement within the Civil Enforcement Area under the partnership agreement between East Suffolk Council and Suffolk County Council.
"ticket"	When relating to a parking event within a charged parking place, means a ticket issued by a pay and display machine operated by the Council obtained for the purpose of showing proof of payment of the relevant parking charge.
"pay and display machine" and "ticket machine"	Means an apparatus designed to accept payment through methods authorised by the Council and issue tickets indicating the payment of the parking charge.
"penalty charge"	Means a sum becoming payable as a result of the contravention of the provisions of this Order, under Sections 72, 73 and 77, and Schedules 7 and 9 of the 2004 Act.
"Penalty Charge Notice"	Means a notice indicating that a penalty charge has been incurred, served either by a Civil Enforcement Officer through attaching it to the vehicle or handing it to the driver, or by the enforcement authority by post to the DVLA registered keeper of the vehicle.
"road"	Means the full width, including footways and verges, of any length of highway or other road to which the public has access, and includes bridges over which a road passes.

“trailer”	Has the same meaning as in Section 136 of the 1984 Act and includes vehicles of Vehicle Certification Agency type approval O1, O2, O3 and O4.
“vehicle of the permitted class”	Means a class of vehicle permitted to be left within a parking place, subject to the provisions of this Order, as set out in Schedule 1 of this Order.
“relevant position”	In the case of a disabled person’s badge, a disabled parking clock or a ticket; this is deemed as being displayed in the relevant position if, in the case of a vehicle fitted with a dashboard or fascia panel, the item is exhibited thereon so all relevant details are legible from outside the vehicle or, in the case of a vehicle not so fitted, the item is exhibited in a conspicuous position on the vehicle so all relevant details are legible from outside the vehicle.
“relevant details”	In the case of a disabled person’s badge, the relevant details are Part 1 (Front) of the badge. In the case of a disabled parking clock, the relevant details are the quarter-hour period during which the parking period began. In the case of a ticket, the relevant details are the time of purchase, the amount paid, the date of purchase, the time of expiry, a reference to the issuing machine, and the correct Vehicle Registration Mark of the parked vehicle.
“sign”	Means a sign of any size, colour and type prescribed or authorised by the Council.
“light commercial vehicle”	Means vehicles of Vehicle Certification Agency type approval N1.

- (2) In this Order, except where the context otherwise requires: -
- (a) any reference to a numbered Article or a numbered Schedule is a reference to the Article or Schedule bearing that number within this Order; and,
 - (b) any reference to a numbered or lettered paragraph or sub-paragraph is a reference to the paragraph or sub-paragraph bearing that number or letter in the Article or Schedule or (in the case of a sub-paragraph) paragraph in which the reference occurs; and,
 - (c) any reference to a Table, or to a numbered Table, is a reference to the Table, or to the Table bearing that number, in the Article or Schedule in which that reference occurs.
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- (4) The regulations imposed by this Order shall be in addition to and not in derogation of any regulation or requirement imposed by any regulations made

under or having effect as if made under the 1984 Act or by or under any other enactment.

- (5) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

PART 2 – DESIGNATION, USE AND CHARGES FOR PARKING PLACES

3 General conditions of use for off-street parking places

- (1) Except as provided for within any other part of this Order, no person shall, except on the direction of or with the permission of an authorised representative of the Council, cause or permit any vehicle to park during the chargeable hours in a charged parking place unless it is a vehicle of the permitted class and/or designated user, and the corresponding parking charge has been paid as outlined in the Schedules of this Order.
- (2) No vehicle shall park in a parking place such that it is not wholly within the markings of a single parking bay or space (within parking places where such marked parking bays are provided), nor shall any vehicle park on any yellow line that does not form part of a parking bay or park in any other obstructive manner.
- (3) No vehicle shall park in a parking place unless the vehicle, and any person who drives it within that parking place, is adequately insured in a manner that complies with the requirements of the Road Traffic Act 1988.
- (4) The engine of a motor vehicle using a parking place must not remain running whilst the vehicle is parked; engines must be stopped as soon as the vehicle is to remain in a stationary position and must not be started unless the position of the vehicle is about to be changed.
- (5) No horn or similar instrument shall be sounded on a vehicle within a parking place except for the purpose of warning another parking place user of the vehicle's presence.
- (6) The hire or sale, or offering of hire or sale, of any thing (including but not limited to items, goods, foodstuffs, skills and services) within a parking place is strictly prohibited unless the written consent of the Council has been obtained, regardless of whether such activities require the use of a vehicle.

- (7) No vehicle shall be sold, hired, or offered and/or exhibited for hire or sale whilst it is in a parking place.
- (8) No work of building, construction, cleaning, engineering, maintenance or repair of any nature shall be carried out within a parking place, except such as may be necessary to enable a vehicle to be moved from the parking place, nor shall any plant, equipment or materials be deposited in a parking place other than with the written consent of the Council, the obtaining of which may require the redress of any loss of income to the Council.
- (9) Cooking, camping or overnight sleeping is not permitted within the boundaries of a parking place, regardless of whether this activity involves the use of a vehicle, unless; the cooking, camping or overnight sleeping is done only within a vehicle classified as a motor caravan, the vehicle is parked in a designated motor caravan parking bay within a parking place where the parking of motor caravans is permitted and, subject to the Schedules of this Order, the appropriate parking charge has been paid for the parking of a motor caravan.
- (10) No person shall use any part of a parking place or any vehicle left in a parking place for the purpose of servicing, washing, cleaning, constructing, maintaining or repairing any vehicle or part thereof other than is reasonably necessary to enable that vehicle to depart from the parking place unless the prior written consent of the Council has been obtained.
- (11) No person shall distribute or affix, or cause to be distributed or affixed, any literature or leaflet of any nature to any vehicle left in a parking place, unless the prior written consent of the Council has been obtained. The Council may seek to recover the costs of the removal and disposal of such literature or leaflets from the person responsible for its distribution.
- (12) No caravan shall enter or be left within a parking place, unless the prior written consent of the Council has been obtained.
- (13) No trailer shall enter or be left within a parking place, unless the prior written consent of the Council has been obtained, or unless; the trailer is being towed by a heavy commercial vehicle, the vehicle is parked in a parking bay designated for heavy commercial vehicles within a parking place where the parking of heavy commercial vehicles is permitted and, subject to the Schedules of this Order, the appropriate parking charge has been paid for the parking of a heavy commercial vehicle.

- (14) No vehicle shall use a parking place unless it is of a vehicle class designated as permitted to use that parking place, as provided for in Schedule 1 of this Order.
- (15) Users of any parking place must abide by any additional terms or conditions displayed on any sign within the parking place.
- (16) The enforcement activities of the Council, or of parties acting on its behalf, are authorised for the parking places specified within this Order and shall be administered in accordance with Part 6 of the 2004 Act and of other enabling powers, and as provided by The Civil Enforcement of Parking Contraventions Designation Order 2020.

4 Designation of Parking Places

- (1) Each area described in Schedule 1 of this Order is designated as a parking place, the extents of such areas to be indicated by appropriate signage, markings or other boundaries (including but not limited to fences, railings, walls and/or other types of divide).

5 Position and Direction of Vehicles

- (1) Subject to a parking place having marked parking bays, no vehicle shall be left in a parking place other than wholly within the confines of a single marked parking bay and, regardless of the provision of marked parking bays, no vehicle shall be left or allowed to stand in a position such as to obstruct the entrance or exit of the parking place, the movement of any vehicle or person within the parking place, any waste receptacles within the parking place, or any ticket machine within the parking place.
- (2) Surface markings and/or signage may be installed for the purpose of indicating the entrance to or exit from a parking place; or indicating that a vehicle using a parking place must proceed in a specified direction within the parking place. No vehicle may be driven so that it enters the parking place otherwise than by an entrance, or leaves the parking place otherwise than by an exit, or in a direction other than that specified.

6 Payment of the Parking Charge

- (1) A parking charge shall be payable upon leaving a motor vehicle within a charged parking place during chargeable hours, the amount of such parking charge being

dependant on the parking period, the class of vehicle / type of user, and the specific parking place being used, as outlined in Schedule 1 of this Order.

- (2) Parking charges are payable by making payment to the value of the parking charge through either:
 - (a) The insertion of coins or the “tapping” of a valid contactless payment card using the ticket machine located within the parking place (unless parking charges within that parking place are payable by cashless payment only as provided for in Article 8(2) of this Order); or
 - (b) The registering of the parking period through a cashless payment method designated and authorised by the Council; or
 - (c) The purchase of a valid permit, where such permits are available and subject to any other terms and conditions specified by the Council, through a method provided by the Council.

- (3) Payment of the parking charge for any parking session for which a parking charge is payable shall be indicated by:
 - (a) The displaying in the relevant position of a valid ticket, showing the relevant details, issued by the parking place’s ticket machine; or
 - (b) The valid return of the vehicle’s Vehicle Registration Mark from the Council’s nominated cashless payment provider(s) for that parking place; or
 - (c) The displaying in the relevant position of a current permit issued by the Council for that parking place and/or parking bay, subject to any additional terms and conditions specified by the Council or, in the case of a virtual permit, the return of the vehicle’s Vehicle Registration Mark from the Council’s enforcement software solution for that parking place and/or parking bay, subject to any additional terms and conditions specified by the Council.

- (4) A parking period for which the parking charge has been paid shall be deemed as expired when:
 - (a) A ticket issued by the ticket machine within the parking place and displayed in the relevant position on the vehicle shows an expiry time earlier than the time the vehicle is being observed; or
 - (b) The Council’s nominated cashless payment provider(s) does not return the vehicle’s Vehicle Registration Mark or returns the Vehicle Registration Mark with an expiry time earlier than the time the vehicle is being observed; or
 - (c) The vehicle has returned to the parking place during the prohibited time in parking places for which a no return period applies as outlined in Schedule 1 of this Order.

- (5) It shall be deemed that the parking charge has not been paid in respect of a parking period for which a parking charge applies if:
- (a) No ticket showing the relevant details is displayed in the relevant position and the Council's nominated cashless payment provider(s) does not return the vehicle's Vehicle Registration Mark; and/or
 - (b) The Vehicle Registration Mark shown on the ticket or returned from the cashless payment provider(s) does not accord with the Vehicle Registration Mark of the parked vehicle; and/or
 - (c) The period of parking for which the parking charge had been paid has expired.
- (6) No parking charge shall be payable in respect of any vehicle parking in a charged parking place during chargeable hours if:
- (a) At the time the vehicle was left in that parking place there was on the ticket machine within that parking place a notice placed by any authorised representative of the Council indicating that the ticket machine within that parking place is out of order; and
 - (b) There is no other functioning ticket machine within that parking place; and
 - (c) The cashless payment service(s) is not available; and
 - (d) If a maximum stay applies within that parking place, the period of parking does not exceed the specified maximum stay.

7 Ticket Machines in Parking Places

- (1) Any ticket issued by a ticket machine within a parking place is not transferable and shall not be valid for any parking period for any vehicle other than the vehicle with the Vehicle Registration Mark recorded on the ticket.
- (2) No person shall insert into a ticket machine relating to the parking place in which the vehicle is left any coins additional to those inserted by way of payment of the parking charge in respect of that vehicle when a maximum stay applies.

8 Cashless Payment in Parking Places

- (1) The Council may, at its discretion, choose to provide a, or a number of, cashless payment method(s) where the applicable parking charge may be paid via an electronic system (including the internet, telephone, SMS and mobile app), by credit card, debit card or other means of secure authorised payment.

- (2) The Council may, at its discretion, deem cashless payment to be the only acceptable method of payment of parking charges in respect of any individual parking place(s) covered by this Order.
- (3) Where a parking charge is paid utilising a cashless payment method provided by the Council, either as a payment option or as the only accepted payment method, a convenience or service charge may also be required to be paid in addition to the parking charge.
- (4) Any parking time purchased through a cashless payment method is not transferable and shall not be valid for any parking period for any vehicle other than the vehicle with the Vehicle Registration Mark provided by the purchaser at the time the parking session was registered.
- (5) Where a parking charge is paid utilising a cashless payment method provided by the Council the purchaser of the initial parking time may, on further payment of the relevant parking charge by the same cashless payment method, increase the length of permitted parking for the vehicle for which the initial parking charge was paid, up to the maximum stay for the parking place in question as outlined in Schedule 1 of this Order.
- (6) The payment of a further charge, as referenced in paragraph (5) of Article 8, does not exempt a vehicle from any penalty charge which may have become applicable for any period between the expiry of a parking session for which the parking charge has been paid and the making of the further payment to extend the paid parking session.

9 Season Tickets

- (1) The Council may issue season tickets subject to availability. Such tickets shall be valid only for the parking place specified unless otherwise confirmed in writing by the Council. The issue and availability shall be at the discretion of the Council on such terms as the Council may from time to time decree.
- (2) Season tickets are purchasable from the Council's appointed cashless payment provider(s), with valid tickets being virtual in type.
- (3) Season tickets shall not entitle the owner of the vehicle to the reservation or sole use of an individual parking bay; use of season tickets may be restricted to certain parking bays and, in such circumstances, season tickets must only be used in accordance with such restriction.

- (4) Season tickets shall be valid only for the parking place, the Vehicle Registration Mark and parking bays specified thereon, and shall not be transferable to another vehicle or parking place.
- (5) In the event of any owner wishing to transfer a season ticket from one vehicle to another in their ownership, an application may be made to the Council, which may be effected at the discretion of the Council and which may attract an administration fee.
- (6) The holder or purchaser of a season ticket shall not be entitled to any refund whatsoever for unused parking time in the event that they no longer require or wish to retain the usage of a season ticket.

10 Maximum Stay and No Return

- (1) No person shall cause or permit a vehicle to wait or be left within a parking place for which a maximum stay duration applies during the hours of operation for any period that exceeds the maximum stay duration specified in Schedule 1 of this Order.
- (2) No person shall cause or permit a vehicle to wait or be left within a parking place for which a no return period applies during the hours of operation for any period, unless the minimum no return period specified in Schedule 1 of this Order has elapsed following the expiry of a previous parking session within the same parking place.

PART 3 – PERMITTED CLASSES OF VEHICLE AND DESIGNATED USERS

11 Class of Vehicles

- (1) Where, as described in Schedule 1 of this Order, a parking place is designated as available for vehicles only of a specified class or classes; no person shall cause or permit any vehicle to enter into or wait within a parking place unless it is of the specified class and any other conditions specified within any part of this Order for that class of vehicle are complied with.
- (2) Where, within a parking place, a parking bay is designated for a specific class of vehicle or category of user, as indicated through the use of appropriate surface markings and/or signage; no vehicle shall be left or allowed to stand in such a

bay unless it is of the specified class or category of user and any other conditions specified within any part of this Order for that class of vehicle or category of user are complied with.

12 Disabled Persons Vehicles

- (1) Where, within a parking place, a parking bay is designated for the use of disabled persons vehicles only, no person shall cause or permit a vehicle to wait or be left within that parking bay unless it is a disabled persons vehicle.
- (2) The driver of a vehicle displaying a disabled persons badge, showing the relevant details in the relevant position, may (subject to compliance with all other provisions of this Order) cause that vehicle to wait or be left within a parking bay designated for the use of disabled persons vehicles only.

13 Loading and Unloading

- (1) Where, within a parking place, a parking bay is designated for loading only, no person shall cause or permit a vehicle to wait or be left within that parking bay unless:
 - (a) The vehicle is being used for the purpose of delivering goods to, or collecting goods from, any premises, or is being loaded from or unloading to any premises; and
 - (b) The delivery, collection, loading or unloading cannot reasonably be carried out in relation to those premises without the vehicle being parked within that parking bay; and
 - (c) The vehicle is so parked for no longer than is necessary and, in any case, for no longer than any time limit stated on any applicable signage and/or surface markings.
- (2) Where, within a parking place, a parking bay is designated for loading by goods vehicles only, no person shall cause or permit a vehicle to wait or be left within that parking bay unless:
 - (a) The vehicle is being used for the purpose of delivering goods to, or collecting goods from, any premises, or is being loaded from or unloading to any premises; and
 - (b) The delivery, collection, loading or unloading cannot reasonably be carried out in relation to those premises without the vehicle being parked within that parking bay; and

- (c) The vehicle is so parked for no longer than is necessary and, in any case, for no longer than any time limit stated on any applicable signage and/or surface markings; and
- (d) The vehicle is a commercial vehicle.

14 Motorcycles

- (1) Where, within a parking place, a parking bay is designated for motorcycles only, no person shall cause or permit a vehicle to wait or be left within that parking bay unless the vehicle is a motorcycle.
- (2) Subject to compliance with all other provisions of this order, any motorcycle parked within the markings of a parking bay designated for the use of motorcycles only shall be exempt from the payment of any parking charge. A maximum stay of 24 continuous hours shall apply, with no return permitted with two hours.

15 Permit Holders

- (1) Where, within a parking place, a parking bay is designated for permit holders only, no person shall cause or permit a vehicle to wait or be left within that parking bay unless:
 - (a) A current physical or virtual permit for which the vehicle has been registered, the vehicle registration mark allocated to the permit to correspond with the vehicle registration mark of the vehicle, is displayed in the relevant position showing the relevant details, or in the case of a virtual permit is returned from the electronic system; and
 - (b) The permit is valid for use within that parking bay within that parking place on the date and time in question; and
 - (c) Any other terms or conditions, imposed at the discretion of the Council in respect of the use of a permit, are also complied with.

16 Motor Caravans

- (1) Where, within a parking place, a parking bay or area is designated for motor caravans only, no person shall cause or permit a vehicle to wait or be left within that parking bay or area unless:
 - (a) The vehicle is a motor caravan, with a length not exceeding 8 metres; and
 - (b) The appropriate parking charge for a motor caravan, as specified within the Schedules of this Order, has been paid for the parking period; and

- (c) The parking period does not exceed any maximum stay or commence within any no return period following a previous parking period specified within the Schedules of this Order as being applicable to motor caravans.
- (2) No awning, gazebo, tent or temporary structure of any kind shall be erected, extended or otherwise placed within a parking place except with the prior written consent of the Council.
- (3) No motor caravan shall park in any parking bay within a parking place unless it is a parking bay designated for the use of motor caravans only.

17 Heavy Commercial Vehicles

- (1) Where, within a parking place, a parking bay or area is designated for heavy commercial vehicles only, no person shall cause or permit a vehicle to wait or be left within that parking bay or area unless:
 - (a) The vehicle is a heavy commercial vehicle and is parked wholly within the markings of a single marked parking bay; and
 - (b) The appropriate parking charge for a heavy commercial vehicle, as specified within the Schedules of this Order, has been paid for the parking period; and
 - (c) The parking period does not exceed any maximum stay or commence within any no return period following a previous parking period specified within the Schedules of this Order as being applicable to heavy commercial vehicles.
- (2) No heavy commercial vehicle shall park in any parking bay within a parking place unless it is a parking bay designated for the use of heavy commercial vehicles only.

18 Coaches and Buses

- (1) Where, within a parking place, a parking bay or area is designated for coaches and/or buses only, no person shall cause or permit a vehicle to wait or be left within that parking bay or area unless:
 - (a) The vehicle is a coach or bus and is parked wholly within the markings of a single marked parking bay; and
 - (b) The appropriate parking charge for a coach or bus, as specified within the Schedules of this Order, has been paid for the parking period; and
 - (c) The parking period does not exceed any maximum stay or commence within any no return period following a previous parking period specified within Schedule 1 of this Order as being applicable to coaches or buses.

- (2) No coach or bus shall park in any parking bay within a parking place unless it is a parking bay designated for the use of coaches and/or buses only.

PART 4 – CONTRAVENTIONS AND PENALTY CHARGES

19 Penalty Charges

- (1) In any such case of any contravention of the provisions of this Order, a penalty charge where appropriate shall be payable to the Council under and subject to the provisions of this Order, the amount of the penalty charge being any amount recommended by the Secretary of State.
- (2) In the case of a vehicle in respect of which a penalty charge may have been incurred it shall be the duty of a Civil Enforcement Officer, employed by the Council or by a third party acting as an agent of the Council, to issue a Penalty Charge Notice in accordance with the provisions of *The Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022* or any subsequent regulations made by the Secretary of State in relation to the issuing of Penalty Charge Notices for parking contraventions.
- (3) Penalty Charge Notices, whether affixed to the vehicle or served via first class post, shall include:
- (a) The vehicle registration mark and make; and
 - (b) The date of the contravention; and
 - (c) The date and time of issue of the Penalty Charge Notice; and
 - (d) The name of the parking place; and
 - (e) A description of the contravention; and
 - (f) A statement that a penalty charge in the amount specified is incurred; and
 - (g) The manner in which and the time within which the penalty charge should be paid; and
 - (h) Any other particulars required by *The Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022* or any subsequent regulations made by the Secretary of State in relation to the issuing of Penalty Charge Notices for parking contraventions.
- (4) The penalty charge shall be paid to the Council within 28 days of the day on which the penalty charge was incurred, through one of the methods stated on the Penalty Charge Notice.

- (5) In the event of a payment being received by the Council within a payment period (including the discount period) on a day on which the Council is closed, the payment period shall be extended until 17:00 on the next full day on which the Council is open.
- (6) Should a penalty charge remain unpaid after a minimum period of 56 days following the day which the penalty charge was incurred a Charge Certificate shall be issued at which stage the penalty charge amount payable is increased to an amount recommended by the Secretary of State.
- (7) *The Civil Enforcement of Road Traffic Contraventions (Representations and Appeals) (England) Regulations 2022* or any subsequent regulations made by the Secretary of State in relation to representations and appeals against penalty charges for parking contraventions shall apply to this Order with regard to the procedures for processing representations to the Council and appeals to a Parking Adjudicator appointed by the Joint Committee.
- (8) *The Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022* or any subsequent regulations made by the Secretary of State in relation to the collection of valid penalty charges for parking contraventions shall apply to this Order with regard to the procedures for the collection of valid penalty charges.

20 Movement and Removal of Vehicles

- (1) Where a vehicle is left in a parking place in contravention of any of the provisions of this Order an authorised representative of the Council or a police officer may remove the vehicle or arrange for it to be removed from that parking place.
- (2) In the case of an emergency an authorised representative of the Council or a police officer may alter the position of any vehicle within that parking place to any place or position thought appropriate.
- (3) Any person altering the position of a vehicle, or removing a vehicle from, within a parking place by virtue of paragraphs (1) or (2) may do so by towing or driving the vehicle, or by any such other manner as thought necessary.
- (4) When an authorised representative of the Council or a police officer removes or makes arrangements for the removal of a vehicle from a parking place by virtue of paragraphs (1) or (2), arrangements shall be made as may be reasonably necessary for the safe custody of the vehicle.

- (5) The Council, regarding any vehicle which has been or could have been removed from a parking place in pursuance of the provisions of this Order; if said vehicle appears to have been abandoned, may sell or otherwise dispose of the vehicle and may recover any expenses or charges reasonably incurred from any person responsible.

PART 5 – EXEMPTIONS AND SUSPENSIONS

21 Exemptions from Prohibitions and Restrictions

- (1) No provision of this Order shall apply to any vehicle on an occasion when it is being used for emergency services operational purposes, including but not limited to police, ambulance, fire and rescue, and coastguard services if the observance of that provision would hinder the use of that vehicle for those purposes.
- (2) Vehicles being used for the purpose of undertaking the statutory duties of the Council, or any other duty authorised by the Council, may be exempted from any provision of this Order provided that:
- (a) The vehicle is owned or leased by, or is otherwise the responsibility of, the Council or its authorised agents; and
 - (b) The vehicle is suitably identifiable as being in the service of the Council or its authorised agents through being liveried as a vehicle of the Council, or through some other appropriate means as authorised in writing by the Council's Parking Services department; and
 - (c) Confirmation of the specific provisions or effective dates for which the exemption has been authorised, or any additional terms or conditions that may apply, has been given in writing by the Council's Parking Services department.

22 Suspension of Parking Places

- (1) The Council may, by Notice or by Order, suspend the use of any parking place or any part thereof, subject to such conditions or exceptions as considered necessary.
- (2) Any person suspending the use of a parking place in accordance with the provisions of this Order shall place in or adjacent to that parking place, or cause to be placed, such signs as are necessary to indicate that parking by all vehicles is prohibited.

- (3) The Council may, at its discretion, determine a fee that is to be paid in relation to any application by any person or organisation for the Council to suspend the use of any parking place in accordance with the provisions of this Order.

PART 6 – MISCELLANEOUS PROVISIONS

23 Rights to Refuse Entry to a Parking Place

- (1) The Council may, via any authorised representative, refuse entry to any parking place, to any person or to any vehicle.

24 Power to Change Schedule Entries

- (1) The descriptive names or locations of parking places within this Order may be changed without changing the effect of the Order.

25 Power to Amend Errors and Omissions

- (1) Where parts of this Order (and any subsequent Amendment or Consolidation Orders) have been misquoted, mis-transposed, omitted or are subject to typographical errors during the compilation process, the text of the Order may be amended without changing the effect of the Order and without need for re-advertisement. The errors, omissions and other alterations covered in this item shall be listed in an errata sheet and appended to the Order.
