

Over £214,904 including VAT (for services or goods)\*  
Over £5,372,609 including VAT (for works)\*

What?	Why?	When?
The rules which govern public sector buys high value goods works and services	1. Set UK regulations 2. Streamline regulations	24 February 2025 onwards Anything started before then subject to current regulations

# What remains the same

- Below threshold remains broadly the same
- Basics of good bidding:
  - Competitive pricing
  - Good quality submissions
  - Reading instructions/questions carefully
  - Following rules set out in tender documents
  - Raising clarifications
  - Checking contract terms
  - Strong social value offering
- Frameworks and DPS will run until the end of their current term

## Differences to be aware of

- Procurement Specific Questionnaire
- Debarment list – effects subcontractors, connected persons and associated persons
- New: Competitive Flexible Procedure
- New frameworks may operate differently
- Higher value contracts (over £5m):
  - KPIs & performance publicly rated
  - Copy of contract published
  - Unsuccessful bidders will be named

# Central Digital Platform

## An upgraded Find a Tender Service

- One site to register on and provide key information
  - Individual code
  - Custom searches and alerts
  - Should link with individual Council's eProcurement sites
- Greater transparency
  - Data reporting
  - Debarment list
  - Performance information



- Mandated by Public Procurement Policy especially those over PPT to allocate at least 10% to Social Value
- The idea is to contribute to the Procurement strategy that aligns with East Suffolk Our direction Strategic goals
- Thriving Economy
- Tackling Inequalities
- Environmental Impact

- Increases chances of winning contracts depending on weightings
- Supplier's commitment to SV demonstrates reputation as a socially responsible organization which fits into ESC goals
- Contributes to the long-term sustainability of the community
- Encourages relationships with Local community
- Aligns with the ESC strategic goals to meet the needs of its community

# In response to Tenders: Do's and Don'ts's

DO'S	DON'TS'
<ul style="list-style-type: none"><li>• Clearly state how your submission support strategic objectives using the Social Value Ask Policy</li></ul>	<ul style="list-style-type: none"><li>• Try not to go out of the scope of the project , however responses should be tailored to the project outcomes</li></ul>
<ul style="list-style-type: none"><li>• Be specific and ensure its proportionate to the Value of Contract , You can include the value worth of SV to be delivered ,Mention Tangible , measurable impacts/outcomes</li></ul>	Don't be ambiguous in your responses
<ul style="list-style-type: none"><li>• Do some research and using the SV policy , identify areas where the SV can make impact stating previous examples and successes</li></ul>	do not state national or generic strategies , you can use the SV Ask measurement
<ul style="list-style-type: none"><li>• Provide past successes and lessons learnt that can be imbedded in the project</li></ul>	Do not include unnecessary details but keep it concise and relevant (watch out for the word count!!!)
<ul style="list-style-type: none"><li>• Demonstrate engagement and consultation with Local communities /stakeholders (Research is highly recommended)</li></ul>	Do not copy and paste from other projects

- Provided furniture to the Battery of Idea's project, which was redundant from the Wilko store



- Crushed and graded concrete material on site for re use in the wider development




- Undertook a local litter pick

Good responses	Poor Responses
<p>-We are dedicated to creating local job opportunities through targeted recruitment strategies, apprenticeship programs, and partnerships with local employment agencies.</p> <p>- Additionally, We will create apprenticeship opportunities for young people and adults, particularly in construction and regeneration fields. By providing on-the-job training and mentoring, we aim to increase the skills base of the local workforce.. For example, we aim to generate X number of jobs within X local community, provide Y hours of training for skill development, and achieve Z% reduction in environmental waste.</p>	<p>"We plan to create jobs and support local businesses."</p> <p>Reasons: it does not quantify or qualify the impact of the proposed activities. The supplier's response presents a challenge for the evaluator to evaluate in terms of tangible benefits due to the absence of measurable outcomes.</p>

A dramatic reduction in carbon is required to meet the UK's 2050 Net Zero commitment. Nuclear power generation can play a key part in the UK's energy mix, providing affordable, reliable low-carbon energy. 

## Goal 3: Reduce the environmental impact of construction


By identifying and acting on opportunities to leave a strong environmental legacy as well as mitigating our impact on the environment.
