

# Thorpeness Community Update

29<sup>th</sup> January 2026

## Current Situation

Demolition of six of the at-risk properties began this week - one cabin style detached building has been removed and a single building containing five apartments is in progress. There are three further properties at risk, but their trigger points for demolition are not yet met.

Over 27m of cliff has been lost since December 2024. Monitoring data shows a slower rate of erosion in the last two weeks. Up to 10m has been lost at the southern end throughout January.

The focus remains on short-term solutions with medium-term plans to be developed.

East Suffolk Council's (ESC) Coastal Management and Adaptation Team have engaged the Anglian Eastern Regional Flood and Coastal Committee (RFCC) regarding potential funding for short-term solutions.

All community proposals for engineering options have been reviewed. Confirmation has been received from ESC's Planning Service that two schemes at the southern end can proceed as permitted development.

ESC has contacted the landowner regarding additional signage for the private road at North End Avenue. Suffolk County Council (SCC) Highways are working on redirecting the King Charles III England Coast Path behind the road.

## Communications

### Local Communications

- A Community Meeting was held on Friday 23<sup>rd</sup> January at Thorpeness Country Club.
- The first community drop-in session was held on Tues 27<sup>th</sup> January at Thorpeness Country Club.
- Further drop-in sessions will be held on 3<sup>rd</sup> and 10<sup>th</sup> February. ESC are providing posters for Aldringham-cum-Thorpe Parish Council to promote the drop-ins.
- Short-Term Solutions – a meeting with key stakeholders has been arranged for Friday 30<sup>th</sup> January (online) to discuss proposals and interlinkages.
- ESC officers to visit a vulnerable resident on North End Avenue on 3<sup>rd</sup> February.
- Save Thorpeness are requesting access to the closed beach. It has been agreed that permission cannot be granted. Parish councillor to respond.
- ESC to arrange a meeting with Save Thorpeness group lead. A response has been provided to their request for data.
- Monitoring data has been shared with residents.


